	Resolution for Improvement by Municipality under Illinois Highway Code		

## **Action Requested**

Approval authorizing the mayor and clerk to sign the Resolution for Improvement by Municipality under the Illinois Highway Code for increased funding for the Florida Avenue and Philo Road Traffic Signal Replacement Project.

## **Background and Facts**

The traffic signals at Florida Avenue and Philo Road are 35 years old and have reached the end of their service life. Additionally, as result of implementing a road diet including bike lanes on Philo Road and Florida Avenue, the traffic signal heads are no longer aligned with the travel lanes for the intersection. Based on these conditions the Engineering Division is recommending the replacement of the traffic signals at Florida Avenue and Philo Road. In addition intersection curb bumpouts will be installed to shorten the pedestrian crossing distance and new streetlights will be installed to light the intersection.

The Public Works Department opened bids on Friday, September 6, 2013 for the Traffic Signal Replacement Project and received one bid from Champaign Signal and Lighting (CS&L) for \$370,836.80 to construct the project. The City Council passed Resolution #2012-07-054R on July 30, 2012 authorizing \$240,000 from State Motor Fuel Tax (SMFT) Funds to finance the project. Project costs for the traffic signal project, including engineering design services, total \$450,000 as shown in the table below.

Florida Avenue and Philo Road Traffic Signal Replacement Project Costs

An additional appropriation of \$210,000 of SMFT funds is needed to construct the project.

The \$240,000 budgeted in the Capital Improvement Plan for the Florida Avenue and Philo Road Traffic Signal Replacement Project did not include the \$58,900 in engineering design fees. Due to staff workload levels in the Engineering Division the design of the traffic signal improvements project was outsourced to an engineering consulting firm. The original preliminary budget amount established in 2012 after a modern roundabout study was performed also did not account for bike detection equipment, curb bump outs with sidewalk replacement to improve pedestrian safety, and temporarily utilizing the existing signal equipment at the intersection while the new signals are constructed.

#### **Financial Impact**

An additional appropriation of \$210,000 from the SMFT funds is needed for the Florida Avenue and Philo Road Traffic Signal Replacement Project. Sufficient SMFT funds are included in the 2013-2014 budget for the additional appropriation required for the Florida Avenue and Philo Road Traffic Signal Replacement Project.

#### **Recommendations**

It is recommended that the resolution authorizing the mayor and clerk to sign the Resolution for Improvement by Municipality under Illinois Highway Code for the additional appropriation for the Florida Avenue and Philo Road Traffic Signal Replacement Project be approved.
