A RESOLUTION TO APPROVE AN EXTENSION OF THE AGREEMENT BETWEEN THE CITY OF URBANA, ILLINOIS AND THE LOCAL #1147 OF THE INTERNATIONAL ASSOCIATION OF FIRE FIGHTERS (TERM OF JULY 1, 2013, THROUGH JUNE 30, 2017)

WHEREAS, the City of Urbana and the duly authorized representatives of Local #1147 of the International Association of Fire Fighters in good faith have negotiated a three-year collective bargaining agreement ("Agreement") with concerning wages, hours, terms, and other conditions of employment for the term of July 1, 2013, through June 30, 2016; and

WHEREAS, the Agreement has been lawfully and properly ratified by the membership of the Local #1147 of the International Association of Fire Fighters and has been approved by the City Council; and

WHEREAS, the parties to the aforesaid collective bargaining agreement seek to extend the terms of such agreement for an additional year (to June 30, 2017) along with other amendments thereto; and

WHEREAS, the membership of the Local #1147 of the International Association of Fire Fighters has approved the above-referenced amendment including extension of contract agreement; and

WHEREAS, the City Council finds that the best interests of the City are served by executing the aforesaid contract extension agreement.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Urbana, Champaign County, Illinois, as follows:

Section 1.

The contract extension agreement to the collective bargaining agreement between the Local #1147 of the International Association of Fire Fighters and the City concerning wages, hours, terms, and other conditions of employment for the term of July 1, 2013, through June 30, 2017, in substantially the form of the copy attached hereto and hereby incorporated by reference, be and the same is hereby authorized and approved.

Section 2.

The Mayor of the City of Urbana, Illinois, be and the same is hereby authorized to execute and deliver, and the City Clerk of the City of Urbana, Illinois, be and the same is authorized to attest to, said execution of said contract in substantially the form appended hereto as so authorized and approved for and on behalf of the City of Urbana, Illinois.

Section 3.

The City Clerk shall transmit a certified copy of this Resolution to the President of the Local #1147 of the International Association of Fire Fighters.

Section 4.

ABSTAINS:

CONTRACT EXTENSION AGREEMENT

This Agreement between the City of Urbana, Illinois (the "City") and Local #1147 of the International Association of Fire Fighters, AFL-CIO, Urbana, Illinois, (the "Union"), sets forth the terms for the one-year extension of the collective bargaining agreement between them which is due to expire at midnight June 30, 2016.

- 1. It is understood that the City and the Union agree to extend all the terms of the current collective bargaining agreement until midnight June 30, 2017.
- 2. Article VIII and Appendix B (1,2,3,4) of the collective bargaining agreement shall be considered changed to reflect the one year extension and effective July 1, 2016, a 3% across-the-board wage increase.
- 3. Article XX shall be considered changed to reflect the extension and that the contract remain in full force and effect until June 30, 2017.
