Introduction: Attached is a Resolution authorizing entering into and execution of a Federal Emergency Management Agency Assistance to Firefighters Grant.

Discussion: The Urbana Fire Department is seeking approval from the Council to accept a Fiscal Year 2014 Assistance to Firefighters Grant from the Department of Homeland Security in the amount of \$20,645.00. As a condition of this award, the City is required to contribute a cost match in the amount of \$2,064 of non-Federal funds, or 10 percent of the Federal contribution of \$20,645.00. The funds are available for the City's contribution in the fire department training line (050-1-1300-3030).

The grant funds, if approved, will be used to purchase a Bullex Attack Digital Fire Training System. This system will allow the firefighters to experience realistic simulated live-fire training in locations and situations that have previously not been available. The system can be utilized with water charged hose-lines or, in situations where water will be destructive to the environment, weighted dry hose-lines utilizing a laser nozzle to simulate extinguishment. This system will work wirelessly with the department's smoke generator to produce scented smoke that will reflect smoke conditions based on the actions of the trainees.

Fiscal Impact: The City's cost match of \$2,064 will be funded as described above. A budget amendment for revenues and expenditures of \$20,645 will be approved in a separate agenda item.

Recommendation: It is recommended that A Resolution Authorizing Entering Into and Execution of a Federal Emergency Management Agency Assistance to Firefighters Grant Agreement be approved.

A RESOLUTION AUTHORIZING ENTERING INTO AND EXECUTION OF A FEDERAL EMERGENCY MANAGEMENT AGENCY ASSISTANCE TO FIREFIGHTERS GRANT AGREEMENT

WHEREAS, the City of Urbana (hereinafter, the "City") is a home rule unit of local government pursuant to Article VII, Section 6, of the Illinois Constitution, 1970, and may exercise any power and perform any function pertaining to its government and affairs, including the power to regulate for the protection of the public health, safety, and welfare; and

WHEREAS, the Urbana Fire Department serves the community by providing effective emergency response services; and

WHEREAS, the City recognizes that effective firefighter training is essential to the services provided by the Urbana Fire Department; and

WHEREAS, the Federal Emergency Management Agency's Assistance to Firefighters Grant Program (hereinafter, the "FEMA AFG Program"), seeks to protect the health and safety of the public and firefighting personnel against fire and fire-related and makes available to firefighting agencies grant monies for projects consistent with this purpose; and

WHEREAS, the City applied for a grant from the FEMA AFG Program and the FEMA AFG Program approved the City's application for a grant in the amount of \$20,645; and

WHEREAS, a condition of acceptance of the FEMA AFG grant monies requires the City to contribute to a cost match in the amount of \$2,064 of non-Federal funds or ten percent of the Federal contribution of \$20,645; and

WHEREAS, the said grant will allow the City to purchase the Bullex Attack Digital Fire Simulator which will provide valuable and essential training opportunities for the Urbana Fire Department by providing fire simulation training without causing damage or destruction to real property; and

WHEREAS, the City Council deems it appropriate for the City to accept, enter into and execute the FEMA AFG Grant Agreement.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Urbana, Champaign County, Illinois, as follows:

<u>Section 1.</u> The Mayor shall be and hereby is authorized to enter into and execute on behalf of the City of Urbana the FEMA Assistance to Firefighters Grant Agreement in form and substance as described.

Section 2. The Mayor shall be and hereby is authorized to undertake such other actions as are or may be necessary in order to carry out the purpose and intent of this Resolution.

- iv. Change in pension value. This is the change in present value of defined benefit and actuarial pension plans.
- v. Above-market earnings on deferred compensation which is not tax-qualified.
- vi. Other compensation, if the aggregate value of all such other compensation (e.g. severance, termination payments, value of life insurance paid on behalf of the employee, perquisites or property) for the executive exceeds \$10,000.

XV. False Claims Act and Program Fraud Civil Remedies

All recipients must comply with the requirements of <u>31 U.S.C.</u> §3729 which set forth that no recipient of federal payments shall submit a false claim for payment. See also <u>38 U.S.C.</u> § <u>3801-3812</u> which details the administrative remedies for false claims and statements made.

XVI. Federal Debt Status
