SUBJECT: Revised Budget Amendment – Various Items

Attached is a revised Budget Amendment Ordinance.

The specific revision is a change in the amount rebudgeted in the Social Services Fund related to relocation of residents of Barnes Mobile Home Park. The actual amount needed for this purpose is \$2,530. (The amount that was originally included was \$25,030.) When combined with \$7,045 in other funds for emergency relocation, the total increase in expenditures for that fund will be \$9,575.

SUBJECT: Budget Amendment – Various Items

Introduction: Attached is an Ordinance revising the FY2015/16 annual budget to provide for items described below.

Discussion:

<u>Social Services Fund</u> – \$25,030 in unspent funds from FY2015 will be "rebudgeted" for a relocation related to acquisition of the Barnes Mobile Home Park. This relocation did not occur until after July 1, 2015. In addition, \$7,045 in unspent funds for other emergency relocation will be rebudgeted. There is no impact on fund balance, since these funds were budgeted, but not spent, in FY2014/15.

<u>Vehicle & Equipment Replacement Fund –</u> Revenues and expenditures of \$20,645 for an Assistance to Firefighters (AFG) grant for fire equipment will be recognized. The City Council will be asked approve the grant agreement as a separate item on this agenda. In addition, interfund transfers from the General Fund will be reduced by \$150,000. This change is related to a reduction in the transfer that was included in the final Budget Ordinance. The fund balance in the VERF will be reduced by \$150,000 to \$4,298,278.

<u>Economic Development Fund</u> – Both revenues and expenditures will be increased by \$5,000 to reflect receipt and expenditure of SNAP (Supplemental Nutrition Assistance Program) grant funds. The grant agreement will be presented separately on this agenda. There is no impact on fund balance.

<u>ARMS Fund</u> – A portion of the salary for an intern position in the Information Technology Division was inadvertently omitted from the budget. This change will increase expenditures in the ARMS Fund by \$3,107, decreasing fund balance by the same amount.

Fiscal Impact: This budget amendment has no impact on the City's General Operating Fund. Although some other fund balances are affected, the changes will not have any significant impact.

Recommendation: Approve the budget amendment.

ORDINANCE NO. 2015-07-082

AN ORDINANCE REVISING THE FISCAL YEAR 2015 - 2016 ANNUAL BUDGET (Various Items)

WHEREAS, the corporate authorities heretofore did approve an annual budget for the City of Urbana ("City") for the fiscal year beginning on July 1, 2015, and ending on June 30, 2016; and

WHEREAS, the corporate authorities find that the best interests of the City are served by revising the annual budget by deleting, adding to, changing or creating sub-classes within object classes and object classes themselves; and

WHEREAS, funds are available to effectuate the purpose of such revision;
and

WHEREAS, the Budget Director may not make such revision under the authority so delegated to her pursuant to 65 ILCS 5/8-2-9.6 or Urbana City Code § 2-133.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Urbana, Champaign County, Illinois, as follows:

Section 1.

The Fiscal Year 2015 - 2016 Annual Budget, as revised, is hereby further revised as set forth in Exhibit A, which is attached hereto and incorporated herein by reference.

Section 2.

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of two-thirds of the corporate authorities then holding office (6 of 8 votes) of the City of Urbana, Illinois, at a meeting of the corporate authorities.
