## **Introduction**

At its September 15, 2015 meeting, the Urbana Traffic Commission recommended parking restrictions at certain locations on Philo Road between Washington Street and 264 feet north of Washington Street.

### **Background**

In January 1997, the Urbana City Council approved Ordinance #9697-77 thereby restricting parking on Philo Road from the centerline of Washington Street to 82 feet north of the centerline of Washington Street to ease congestion created by on-street parking on the east side of Philo Road. Since the passage of the ordinance, vehicles have been parking on an unimproved shoulder that is not wide enough to entirely accommodate the vehicles. The Urbana Traffic Commission recommended parking restrictions on the shoulder at locations where cars cannot safely park. To accomplish this, the Traffic Commission recommended removing the current restriction approved in 1997, and adding to the ordinance (Schedule J) for parking restrictions on Philo Road from Washington Street to 104 feet to the north of Washington Street and from 160 feet north of Washington Street to 264 feet north of Washington Street to clarify where onstreet parking would be allowed. Some patrons of the restaurant (Huaraches Moroleon located at 805 South Philo Road) had been parking on Philo Road when the parking lot was full. If the restrictions are approved, the City plans to widen to the east shoulder of Philo Road and designate the area where parking would be permitted to prevent damage to the shoulder of the road, avoid rutting the parkway grass and keep parked vehicles away from the travel lane on Philo Road.

### Recommendation

It is recommended that Council approve an Ordinance Amending Schedule J of Section 23-183 of the Urbana Local Traffic Code Prohibiting Parking at All Times on Certain Streets (Philo Road).

# AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-183 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING AT ALL TIMES ON CERTAIN STREETS

#### (Philo Road)

WHEREAS, the City of Urbana ("Urbana") is an Illinois Municipal
Corporation pursuant to the Illinois Constitution of 1970 and the Statutes of
the State of Illinois;

WHEREAS, the City of Urbana has adopted a local traffic code which is set forth in its ordinances as Section 23.1 et seq.; and

WHEREAS, the City of Urbana, pursuant to the aforesaid traffic code, has the authority to regulate parking on its streets and in its parking lots; and

WHEREAS, the City of Urbana restricts parking on streets to provide public safety and access;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-183, entitled "Parking Prohibited At All Times on Certain Streets" of Article XIV of the Urbana Local Traffic Code, is hereby amended by DELETED from that schedule the following portions of streets where no person shall be permitted to park a vehicle at any time:

<u>Street</u> <u>Between</u> <u>Side of Street</u>

Philo Road From the centerline of East Side

Washington Street to 82 feet north of the centerline of Washington

Street

Section 2. That Schedule J of Section 23-183, entitled "Parking Prohibited At All Times on Certain Streets" of Article XIV of the Urbana

Local Traffic Code, is hereby amended by ADDING to that schedule the following portions of streets where no person shall be permitted to park a vehicle at any time:

Street	Between	Side of Street
Philo Road	From the centerline of Washington Street to 104 feet north of the centerline of Washington Street	East Side
Philo Road	From 160 feet north of the centerline of Washington Street to 264 feet north of the centerline of Washington Street	East Side

Section 3. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 4. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 5. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a meeting of said Council.

# ORDINANCE NO. 9697-77

AN ORDINANCE AMENDING SECTION 14-3 OF THE URBANA LOCAL
TRAFFIC CODE PROHIBITING PARKING ON CERTAIN STREETS
(CRYSTAL LAKE DR., CEDAR ST., MAIN ST., PHILO RD., TATMAN CT.)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of §14-3, entitled "Parking Prohibited at All Times on Certain Streets", of Article XIV of the Urbana Local Traffic Code, under the heading, "No Parking Either Side", is hereby amended by deleting from that schedule the following portion of a street where no person shall park a vehicle:

Crystal Lake Drive From Cunningham Av. to Maple St.

Section 2. That Schedule J of §14-3, entitled "Parking Prohibited at All Times on Certain Streets", of Article XIV of the Urbana Local Traffic Code, is hereby amended by adding to that schedule, under the heading "No Parking This Side of Street," the following portions of streets where no person shall park a vehicle:

Side of Street

Crystal L Drive	ake Westbound	From Maple St. to Cunningham Av.	North
Cedar	Northbound	From centerline of Green St. to 110 feet south of centerline of Green St.	East
Main	Westbound	From centerline of Poplar St. to 113 feet east of centerline of Poplar.	North
Philo	Northbound	From centerline of Washington St. to 82 feet north of center- line of Washington St.	East

Section 3. That Schedule J of §14-3, entitled "Parking Prohibited at All Times on Certain Streets", of Article XIV of the Urbana Local Traffic Code, under the heading, "No Parking Either Side", is hereby amended by adding to that schedule the following portion of a street where no person shall park a vehicle:

Tatman Ct. From High Cross Rd. to end of Tatman Ct.

<u>Section 4.</u> All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 5. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 6. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at aspecial meeting of said Council.
