





SQFT ADDED: Commercial / Industrial and Multi-Family residential added SQFT reached post-recession highs in 2015, the highest since 2007. Single-Family residential SQFT added remained constant, however, the new Urbana Enterprise Zone is expected to spur Single-Family residential construction growth.

Research & Analysis

FLASH INDEX:

The U of I Flash Index provides a fast look at the performance of the Illinois economy. The Flash Index increased to 106.1 in November from 105.8 in October ending a three-month downward trend. In December the Index fell to 105.5, the lowest since March 2013.

HOME VALUES:

Home values increased by 0.3% from September 2015 to October 2015. Urbana has seen an estimated annual increase in home values of 3.5%, higher than Champaign's 1.2% annual increase. In December 2015, home values were estimated to have decreased by 0.1%. *Source: Zillow.com Local Market Overviews*

Compared to December 2014, the median home sale price in the Champaign County area increased by 2.1% in December. The number of home sales increased from 2014 to 2015 by 4.0%. A total of 2,780 homes were reported sold, the highest annual volume since 2007. From 2014 to 2015, City of Urbana home sales increased by 6.8%. *Source: CCAR Newsletter* 1/15/2016
