Professor Francis Boyle addressed the committee in support of Sanctuary Cities and read an article from the New York Times(Editorial published 12-19-16) for the record as follows: A recent <u>Global Strategy Group</u> poll found that Americans oppose, 58 percent to 28 percent, repealing President Obama's DACA program, which shields the young immigrants called Dreamers from deportation. A <u>Quinnipiac poll</u> taken after the election found that Americans strongly support - 72 percent to 25 percent - allowing unauthorized immigrants to stay, with 60 percent supporting a path to citizenship. This support is higher than at any point in the four years it has been asking the question, <u>Quinnipiac said</u>.
