## 1. CALL TO ORDER AND ROLL CALL

## 16. Closed Session Minutes Review

As the last item of the regular meeting, the Committee went into closed session for the purposes of reviewing Closed Session minutes pursuant to 5 ILCS 120/2(c)(21) at 9:56pm (Moved by Alderman Ammons, seconded by Alderman Miller) following a roll call vote: Voting Aye: Ammons, Hazen, Miller, Roberts, Wu, Mayor Marlin; Voting Nay: none

The members of the City Council, Mayor Marlin, and City Attorney James Simon moved to the 2<sup>nd</sup> floor executive conference room. Chief Morgan remained in the Council Chambers and all other staff and attendees left.
