Re: IDOT Distracted Driving Grant

Introduction: The purpose of this memorandum is to inform the Mayor and City Council of a grant the Illinois Department of Transportation (IDOT) has offered to the City of Urbana Police Department (UPD). The grant, in the amount of \$6,300, is through IDOT and is titled Distracted Driving Grant. IDOT has awarded the grant to UPD and is awaiting acceptance by UPD.

Action Requested: I respectfully ask the Council to approve the resolution to accept the grant.

Background: IDOT has selected the Urbana Police Department as a partner to focus on distracted driving. Between April 16, 2018 and April 30, 2018, the Urbana Police Department will utilize five STEP details consisting of four officer each to focus on incidents of distracted driving, and officers will take appropriate enforcement action.

Budget Impact: There will be no budget impact, as there is no local match required for this grant.

Staffing Impact: The STEP coordinator will monitor the details, which will be scheduled during normal STEP detail dates and times.

WHEREAS, the City has applied for and been offered a grant pursuant to the grant program established by the Illinois Department of Transportation to undertake a study on the issues of distracted driving and driving without using a seatbelt; and

WHEREAS, the City Council deems it appropriate to accept the aforesaid grant and undertake the work required thereby.

NOW, THEREFORE, BE IT RESOLVED by the City Council, of the City of Urbana, Illinois, as follows:

Section 1.

The Mayor of the City of Urbana, Illinois, shall be and hereby is authorized to accept, on behalf of the City, the Illinois Department of Transportation grant as attached hereto and made a part hereof as an exhibit.
