RE: Replacement of the existing brick sidewalk on Anderson Street between East High

and East Green Streets with a new concrete sidewalk.

Action Requested

Approval of a motion for the replacement of the existing brick sidewalk on Anderson Street between East High and East Green Streets with a new concrete sidewalk.

Background and Facts

In the 1970s, the City Council adopted a resolution which prohibited the replacement of brick sidewalks with anything but brick. In 1988, the City Council made an exception to that policy and approved a conversion of two locations to concrete because they were in poor condition and were isolated pieces of brick sidewalk. City Council adopted Ordinance Number 2002-02-014 on February 18, 2002 that established new requirements regarding the repair and replacement of brick sidewalks. The new ordinance identified certain existing brick sidewalks as "Major Brick Walk" areas that require Council approval to be replaced by a concrete sidewalk. Ordinance 2002-02-014 states that for "Major Brick Walk" areas a waiver may be granted by a motion passed by majority vote of the alderpersons holding office to allow a brick sidewalk to be replaced with a concrete sidewalk.

Illinois American Water is installing a new water main on the west side of Anderson Street between East Green and East High Streets that required the removal of the existing brick sidewalk for the entire block. All of the property owners on the west side of that block, which includes 607 East Green Street, 305 Anderson Street, and 608 East High Street, have requested to Public Works staff that the brick sidewalk be replaced with a new concrete sidewalk. The property owner requests for the concrete sidewalk are included in Attachment A.

The existing brick sidewalk is in a "Major Brick Walk" area as identified in Section 20-31 of the City Code and requires Council approval to be replaced with a concrete sidewalk. The location of the brick sidewalk requested for replacement with a concrete sidewalk is shown in Attachment B.

The property owners are concerned about tripping hazards associated with the existing brick sidewalk that have resulted in falls for guests visiting those properties. They are also concerned about the maintenance of brick sidewalks since the existing sidewalk is completely overgrown with vegetation and in poor condition. Photos of the condition of the existing sidewalk prior to its removal are shown in Attachment C.

The sidewalk ramps at the intersections of High Street and Green Street will be replaced with concrete even if the sidewalk is to remain in brick in order to meet the current Public Rights-of-Way Accessibility Guidelines (PROWAG) requirements.

Financial Impact

There are no costs associated with replacing the existing brick sidewalk with a new concrete sidewalk for the City. Illinois American Water will have to replace the existing sidewalk as part of their water main replacement project.

Recommendations

It is recommended that a motion for the replacement of the existing brick sidewalk on Anderson Street between East High and East Green Streets with a new concrete sidewalk per City standards be approved.




