Setting annual schedules will be on agendas for December 9, 2019 Cunningham Town Board and Urbana City Council Committee of the Whole (COW) meetings. To prepare potentially necessary rules changes, I am requesting some discussion and feedback at City Council on Monday, December 2.

## Proposed: City of Urbana, swap COW $/$ City Council days to $1^{\text {st }} / 3^{\text {rd }}$ and $2^{\text {nd }} / 4^{\text {th }}$ Mondays

As council has requested that some Plan Commission items go to committee first, this would allow sufficient time to prepare materials post-Plan Commission meetings. Since Council Members already meet every Monday night, swapping nights has no impact on Council. The impact is to Planning Staff who could have a $2^{\text {nd }}$ meeting to attend. However, this is already occurring per recent council directive. Staff would continue to route more routine Plan Case matters directly to Council using the council directive though when there are questions, such as the case being heard on December 2 , these can also be routed to the COW first. The negative impact is that this adds a week to all plan cases that involve council action regardless of the directive. However, this also keeps directive-based items from taking even longer. The other positive aspect is that Plan Commissioners, who generally meet twice monthly and have a long-established schedule, are unaffected. Our goal is to minimize the need for special meeting but deadlines and schedules may necessitate them.

Rules changes: If the council meeting schedule goes to second/fourth $C C, 1^{\text {st }} / 3^{\text {rd }} C O W$, there will need to be a small change to the current ordinance regulating council meetings. The change would be brought to council for the meetings of December 9 and December 16. This would be an opportunity to make other changes to council rules as well (see below).

City Council Rule 4, the Resolution on Resolutions, was readopted with an amendment allowing resolutions from city commissions and boards, by Resolution 2017-07-045R. However, as shown by several recent examples related to accepting grants and reimbursements, this rule can be burdensome. Frankly, it is no longer necessary as other rules and statutes that did not exist when this rule was created now clarify processes. Historically, this rule was adopted to provide time for council to conduct public business before the clear requirements for Public Input as defined by the Open Meetings Act (OMA) and city ordinance that provide limits. Further, per OMA, items not listed on the agenda in advance of a meeting can't be voted on for final action, something that was expected many years ago when this rule was created. Our recommendation is to delete this council rule whether or not council meeting schedule changes.

In talking with Supervisor Chynoweth, Assessor Williams, Mayor Marlin, City Administrator Mitten, as well as staff, there is interest in setting regular Township meetings at 6:30 pm to last approximately 30 minutes. The advantage is that city staff would not have to be in attendance until 7 , the disadvantage being that next meetings would have to wait until 7 pm if the meeting finished early. However, most Township meetings have been lasting around 30 minutes and any special meetings that are expected to be quick, could be scheduled for 6:45 or even 7 pm as judgement suggests. The Township would also move to meeting on the $2^{\text {nd }}$ Monday if council meetings move.

December 23, Committee of the Whole meeting: As a holiday week, we may not have a quorum - Please let us know your availability. Possibilities include cancelling this meeting outright or rescheduling it to follow the Dec. 16 Council Meeting for critical items that need to be passed at the first City Council Meeting in January. This can be decided at the December 9 COW meeting. Also note that December 30 is a fifth Monday with no meeting.

Bulky packet items: There was an AT\&T Agreement document several weeks ago that was rather lengthy, exceeding 25 pages, something like 75 . Is there a rough length we can use as guidance where we can direct council to an online version rather than printing it off for packets? We currently print 12 copies of every packet pending selection of a PW Director. One of these copies is stored permanently per state retention rules.
