A RESOLUTION REGARDING THE RELEASE OF CERTAIN CLOSED SESSION MEETING MINUTES AND APPROVING THE DESTRUCTION OF CERTAIN VERBATIM RECORDS OF CLOSED SESSION MEETINGS

(For the period ending January 31, 2020)

WHEREAS, Section 2 of the Open Meetings Act (the "Act"), 5 ILCS 120/2, authorizes public bodies to hold closed session meetings to consider those subjects listed in such Section; and

WHEREAS, the City Council heretofore has met from time to time in closed session for

purposes authorized by the Act; and

WHEREAS, the City Clerk has kept written minutes of all such closed session meetings, as required by the Act; and

WHEREAS, Subsection (d) of Section 2.06 of the Act, 5 ILCS 120/2.06(d), requires each public body to conduct a semi-annual review of all closed session meeting minutes not previously released to the public to determine whether the need for confidentiality still exists as to all or part of those minutes; and

WHEREAS, pursuant to said subsection, the City Council has met in closed session to review all previously unreleased closed session meeting minutes; and

WHEREAS, the City Council has determined that all or part of the closed session meeting minutes listed in Schedule A of this Resolution no longer require confidentiality to protect the public interest or the privacy of any individuals; and

WHEREAS, the City Council further has determined that the need for confidentiality still exists as to the minutes from those closed session meetings set forth in Schedule B of this Resolution; and

WHEREAS, Section 2.06 of the Act, 5 ILCS 120/2.06, requires all public bodies to keep verbatim records of all closed session meetings in the form of audio or video recordings; and

WHEREAS, the City Clerk has kept such records as required by the Act; and

WHEREAS, Subsection (c) of Section 2.06 of the Act, 5 ILCS 120/2.06(c), authorizes a public body to destroy such verbatim records without notification to or the approval of a local records commission or the State Archivist no less than 18 months after the completion of the meeting recorded, but only after the public body approves the destruction of a particular recording and approves written minutes of the closed meeting; and

WHEREAS, no less than 18 months have passed after the completion of the closed session meetings listed in Schedule C of this Resolution; and

WHEREAS, the City Council heretofore has approved the written minutes of such meetings; and

WHEREAS, the City Council has determined that the verbatim records of the closed session meetings listed in Schedule C of this Resolution no longer need to be retained and are authorized for destruction.

NOW, THEREFORE, BE IT RESOLVED by the City Council, of the City of Urbana, Illinois, as follows:

Section 1.

The closed session minutes, or portions thereof, from those meetings set forth in Schedule A, attached hereto and hereby incorporated by reference, are hereby released.

Section 2.

Upon approval of this Resolution, the City Clerk is directed to post such minutes on the City of Urbana's website and to make such minutes available for public inspection, in accordance with the City Clerk's standard procedures and the governing regulations in the Open Meetings Act. Further, the City Clerk is directed to maintain the confidentiality of the closed session meeting minutes set forth in Schedule B, attached hereto and hereby incorporated by reference.

Section 3.

The verbatim records of the closed session meetings set forth in Schedule C, attached hereto and hereby incorporated by reference, are hereby approved for destruction.

Section 4.

Upon approval of this Resolution, the City Clerk is directed to destroy such records in accordance with the City Clerk's standard procedures.
