**RE:** Questions and Comments Received on the Proposed Fiscal Year 2020/2021  
Liquor License Fee Schedule

**Introduction**

Included in this memo are answers related to questions and comments received from members of City Council and current liquor license holders regarding the proposed fiscal year 2020/2021 liquor license fee schedule. The Urbana City Code requires revisions to the Schedule of Fees be reviewed by the City Council and put on file with the City Clerk's Office at least thirty (30) days prior to final action by the City Council. During that time, the Schedule of Fees is available for public inspection and comment.

**Background**

On February 24, 2020, City Council approved Ordinance No. 2020-02-005 consolidating twenty-seven (27) classes of liquor licenses to twenty (20) classes of liquor licenses and eight (8) optional rider classifications, a complete revision of Urbana City Code Chapter 3 – Alcoholic Liquors (UCC Ch. 3). On April 20, 2020, City staff presented a proposed liquor license fee schedule for the 2020/2021 fiscal year to reflect the approved changes in the license categories.

The packet of information that was provided at the April 20, 2020 City Council meeting was sent to all current liquor license holders on April 24, 2020 to solicit their feedback, questions, and concerns.

As of the writing of this memo, the Liquor Commissioner and staff have received questions and comments from two Urbana City Councilmembers and two liquor license holders.

**1. Class INC – Incubator License renewal period and rationale for fee of \$4,000 (from Councilmembers Wu and Miller)**

This license classification was created in response to requests for an additional license to accommodate new business models that do not fit into any of the current license classifications. The license would be for a six (6) month period and would be eligible for a one-time renewal of one hundred eighty (180) days at the end of the initial period. The proposed \$4,000 fee would be split for each six (6) month period.

Rather than create a new license each time somebody proposes a new type of business, City Council approved of the Class INC license that gives entrepreneurs an opportunity to explore creative business models. If the model works, if others want to do the same thing, etc., then we could decide

to create a new license class. This would be more efficient on both sides compared to drafting new code language that would have to be approved by City Council, followed by City Council approval of the license itself. Class INC licenses require discussion and approval by City Council, same as any other classification.

The fee is proposed at \$4,000 because of the requirements and staff time involved in the process. The Class INC license would involve extra work by staff because it is a custom-approach for a business model and license that does not otherwise fit into the approved code. Proposals will require meetings with clients, some may require security plans or require additional review by Public Works or Building Safety, depending on what is proposed. Staff will also have to review the applicant's business plan to ensure that the business model meets all state and local requirements. Ultimately, the Local Liquor Commissioner will still determine whether to bring the proposed license to City Council for approval, as she does now.

**2. Class MB-2 – Microbrewery License rationale for fee increase from \$50 to \$3,000 (from Councilmember Miller)**

An MB-2 Microbrewery license in our current code allows for the manufacture, storage, sale to other liquor licensees, and sale to the public for on- or off-premises consumption in *conjunction* with a separate class of liquor license. Instead of requiring the business owner to pay for two licenses, the revised MB-2 license in the code that will go into effect on July 1, 2020 has combined the two licenses required into one self-contained classification for approximately the same amount of total fee.

**a. Example.** 25 O'clock Brewing Company currently has MB-2 Microbrewery license, Class BW Sidewalk Café license, and Class B Beer license (beer of their own manufacture) for a total of \$2,946. The new MB-2 license includes the sale of all beer, wine, and liquor (regardless of manufacturer), and the Class BW Sidewalk Café license is now free for a total of \$3,000. In addition, package liquor sales were incorporated in the current classification, and remain in the forthcoming liquor code, as well.

**3. An Increase in Fees for certain License Classifications (Michael Madigan, owner of Hickory River Smokehouse)**

**Recommendation**

The Office of the Local Liquor Commissioner and the City Attorney recommend sending the Proposed Fiscal Year 2020/2021 Liquor License Fee Schedule provided by the Finance Department to the City Council meeting on May 26, 2020 for approval.

This past Monday evening, the City Finance Department presented their proposed fee schedule for liquor licenses for the upcoming 2020-21 year to the City Council Committee of the Whole. This remains on file for public comment for 30 days. I wanted to make you aware of this so that you could take a look at the new classifications and the proposed costs associated with them.

I also wanted to relay that there are current updates on several grant and loan programs and webinars for small businesses, non-profits and minority business support. Please apply as soon as possible with your banker for the Paycheck Protection Program, with the SBA for the Economic Injury Disaster Loan (EIDL) and note the deadline of next Tuesday, April 28th for the LISC Small Business Relief Grants.

#### GRANTS AND FINANCIAL ASSISTANCE:

##### Paycheck Protection Program

The SBA is currently unable to accept new applications for the Paycheck Protection Program based on available appropriations funding, however, you should still reach out to your partner banker as they may still be able to help you as funds were replenished on April 24th but aren't expected to last long. SBA Economic Injury Disaster Loan Program (EIDL) & Economic Injury Disaster Loan Advance: SBA is unable to accept new applications at this time for the Economic Injury Disaster Loan (EIDL) – COVID-19 related assistance program (including EIDL Advances) based on available appropriations funding. Applicants who have already submitted their applications will continue to be processed on a first-come, first-served basis. ##### LISC Small Business Relief Grants

As Kate indicated, you should save over \$600 on the Food Hall by switching to an R&T license. Furthermore, if your liquor sales are 10% or less of the overall food and beverage sales in the Food Hall, you'll get a discount on the license fee. The new code and fee structure were written with the overall good of the small business community in mind, and to reduce the number of "custom" liquor licenses that had sprung up over the years. We addressed that through the use of basic licenses and riders, as well as adding the "incubator" license for new business concepts to increase flexibility and fairness.

My responses are in blue to your last two emails:

So, just to clarify.

Class A goes from \$5730 to \$4000. Approximately 30% discount, which I assume is the majority of all license holders. This is not the majority of all license holders. Only 13 of our 80 license holders currently have a Class A. It is also possible that that number will decrease in the new licensing year, as well, with the addition of the R&T licenses. No added benefits outside of the discount. Our intent in the revision of the code and streamlining basic license classifications was to mimic Champaign in that there is no differentiation between wine bars/beer only bars/beer and wine bars/and other bar establishments. Now, the new Class A fee proposal is \$4,000; an additional \$1,000 less if beer and/or wine only.

Breweries (MB-2) goes from \$2865 to \$3000 and can sell their own product PLUS beer, wine, AND liquor (MB-2). \$135 increase to sell everything a Class A has at \$3000 instead of \$4000. Microbreweries have been and remain a separate classification entirely from regular bars in that their business is also responsible for manufacture of product. Just as R&T licenses remain a separate classification entirely from regular bars in that bona fide meals are one of the primary services of their business.

All three of the businesses I am associated with go from \$2865 to \$3000. A 4.5% increase with no added benefits. Again, our intent in the revision of the code and streamlining basic license classifications was to mimic Champaign in that there is no differentiation between wine bars/beer only bars/beer and wine bars/and other bar establishments. Analog and Sipyard were the only bars in Urbana that had their own special classification of license. Each of those licenses will see an increase of \$135 when changing to the Class A. As stated in my earlier email, I estimate that Broadway Food Hall applying for a R&T-2 license will result in a

cost savings of \$615 for that license fee.

Also, I am not entirely sure of what breweries or grocery stores were paying previously under the various Class Bs, but I would also like to know the change in fees and whether they benefited from the new LL. Hi Matt –

You are correct in that the traditional Class A liquor license that provides for drink and package consumption on- and off-premises is morphing into a lower-fee classification. With the passage of the new liquor code this past spring (which goes into effect July 1, 2020), the new Class A license is a strict on-premises license with a proposed \$4,000 fee. The beer & wine only option for a Class A allows for an additional \$1,000 reduction in the fee.

In the code revision, the 3 variations of the Class B license (to include Class B, Class BB, and Class BBB) were eliminated. These licenses accounted for approximately 11 licenses: 2 microbreweries, 4 grocery stores, 2 gas stations, 2 bars, and 1 food hall. And in truth were all over the map. Class B Licenses allowed for beer retail for consumption on- or off-premises. Class BB Licenses allowed for beer/wine retail for consumption on- or off-premises. Class BBB Licenses allowed for beer/wine for consumption off-premises only.

In the new liquor code these various licenses were placed within a more consistent, fair, and efficient structure which was the intent of the rewrite:

- The 2 microbreweries now have a self-contained license under the MB Class
- The 6 grocery stores and gas stations now join the other 23 grocery stores and gas stations who have Package Liquor licenses

The remaining 3 licenses are for the wine bar, the food hall, and the Sipyard license which houses 3 different businesses: cafeteria and co, colab, and Sipyard (your licensed establishments).

- Analog currently has a Class BB (\$2865). The move to a Class A would result in a \$135 increase in license fee (\$3000).

- Sipyard et al. currently has a Class BB (\$2865). The move to a Class A would result in a \$135 increase in license fee (\$3000).
- Broadway Food Hall currently has a Class BB (\$2865). The move to a R&T-2 would result in a \$135 increase in license fee (\$3000). However, there is a provision written into the new code that if liquor sales are beneath 10% of total sales there will be a 25% reduction in the fee. This would result in a \$615 decrease in license fee (\$2,250).

I cannot speak to your anticipation that “with more hard liquor bars this may impact any sort of family atmosphere in downtown”. What I do know is that there was significant request for greater availability for all ages in our Class A establishments and we took those requests into account when rewriting the code. For example, these two provisions are in the new code:

- Class A Licensed Establishments (Sec. 3-46 (a) (1) p16) A Class A licensee may elect to permit or allow persons age eighteen (18), nineteen (19) and/or twenty (20) to frequent or remain in any public area of the premises if the local commissioner is provided with a written notice. Please note, a Class A licensee may, but is not required to, allow persons under age eighteen (18) who are accompanied and remain accompanied by a parent or a verifiable legal guardian to be on the premises.
- All Ages Live Entertainment Event Rider (Sec. 3-54 (a) (2) p30) Persons between the ages of fourteen (14) and seventeen (17) may be allowed to attend the licensee’s live entertainment event subject to conditions set forth in the proposed code (without presence of verifiable legal guardian). The live entertainment must conclude no later than 11:00 p.m. Persons between the ages of fourteen (14) and seventeen (17) may be present only during the live entertainment or within one (1) hour before and after the live entertainment event.

Additionally, several of our traditional Class A establishments now qualify for the new R&T licenses which also better allow for all ages to be present in establishments where bona fide meals are regularly prepared and served as one of the primary services of the business. This models what Champaign does in its vibrant downtown area.

I hope that these explanations have helped in your understanding of the changes.

Thanks Kate, so I note that full liquor licenses decreased (~\$5600 to \$4000) while beer and wine licenses or restaurants that only do beer and wine increased (~\$2800 to \$3000 or \$3500).

Is there an explanation for why businesses that do not want to operate as a full bar pay more in this system?

Seems to encourage businesses that only had beer and wine to go full liquor for only \$1000 more.

I anticipate with more hard liquor bars this may impact any sort of family atmosphere in downtown.

Of course, I am happy to have a nightlife in downtown that extends past midnight, it just seems there is not much of a distinction between full liquor vs. beer and wine establishments, where in fact beer and wine establishments are now more costly to operate.

## GRANTS AND FINANCIAL ASSISTANCE:

### Paycheck Protection Program

The SBA is currently unable to accept new applications for the Paycheck Protection Program based on available appropriations funding, however, you should still reach out to your partner banker as they may still be able to help you as funds were replenished on April 24th but aren't expected to last long. Applicants who have already submitted their applications will continue to be processed on a first-come, first-served basis. ### LISC Small Business Relief Grants

This program supports small businesses and enterprises impacted by COVID-19 across the country, especially those in underserved communities, including entrepreneurs of color, women- and veteran-owned businesses that often lack access to flexible, affordable capital. **ORDINANCE NO. 2020-04-022**

**AN ORDINANCE AMENDING URBANA CITY CODE CHAPTER 14, SECTION 14-7,  
REGARDING SCHEDULE OF FEES SUBSECTION A – “LIQUOR LICENSES”**

**(July 1, 2020 through June 30, 2021)**

**WHEREAS**, the City of Urbana (“City”) is a home rule unit of local government pursuant to Article VII, Section 6, of the Illinois Constitution, 1970, and may exercise any power and perform any function pertaining to its government and affairs, and the passage of this Ordinance constitutes an exercise of the City’s home rule powers and functions as granted in the Illinois Constitution, 1970; and

**WHEREAS**, the City Council heretofore has enacted Urbana City Code Section 14-7 to establish a Schedule of Fees for the various licenses, permits, fines, and other fees required under the Urbana City Code; and

**WHEREAS**, the City Council, after due consideration, finds that amending the Schedule of Fees as herein provided, pursuant to Urbana City Code Section 14-7(a), is in the best interests of the residents of the City and is desirable for the welfare of the City’s government and affairs; and

**WHEREAS**, a written copy of the proposed fiscal year 2020– 2021 Schedule of Fees for the various licenses, permits, fines, and other fees required under the Urbana City Code was filed with the City Clerk at least 30 days prior to this date; and

**WHEREAS**, the City Clerk has mailed a copy of such proposed schedule to each member of the City Council, has made such schedule available for public inspection or copying, and has given notice of the availability of such proposed schedule for inspection by publication of a notice of such in a newspaper of general circulation in the City at least 14 days prior to this date.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Urbana, Illinois, as follows:

**Section 1.** Urbana City Code Chapter 14, “Licenses and Permits,” Section 14-7, “Schedule of fees,” subsection (A), “Liquor Licenses,” is hereby amended and as amended shall read as set forth in the Schedule which is attached hereto and incorporated herein by reference.

**Section 2.** Those sections, paragraphs, and provisions of the Urbana City Code that are not expressly amended or repealed by this Ordinance are hereby re-enacted, and it is expressly declared to be the intention of this Ordinance not to repeal or amend any portions of the Urbana City Code other than those expressly set forth as amended or repealed in this Ordinance. The invalidity of any section or provision of this Ordinance hereby passed and approved shall not invalidate other sections or provisions thereof.

**Section 3.** This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

**Section 4.** The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect on and after July 1, 2020.

This Ordinance is hereby passed by the affirmative vote, the “ayes” and “nays” being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a meeting of said Council.
