FUND FY 20-21

Introduction

This memorandum is to provide funding recommendations to the Urbana City Council and Cunningham Township Board for social services agencies who have applied to the Consolidated Social Service Fund (CSSF). CSSF combines funds from three sources: City of Urbana general funds, Cunningham Township funds, and City of Urbana Community Development Block Grant (CDBG) funds. Grants are awarded to agencies following a fair application process and review process, and Council and Town Board approval. The CSSF Committee provides technical assistance for applicants and reviewed all submissions before making funding recommendations. The Committee consists of Sheila Dodd and Alyssa Jaje from the City of Urbana, Danielle Chynoweth from Cunningham Township, and Council member Maryalice Wu.

Discussion

Requests to fund 31 programs were received for the FY20-21 CSSF program. Applications were due February 28, 2020, at 4:00 pm via email. Initially, City and Township staff intended to bring funding allocations to the Committee of the Whole in mid-April and make funding available to agencies July 1, 2020. However, the COVID-19 pandemic caused delays in the review process. On May 26, 2020, City Council and Town Board approved postponing funding decisions to allow agencies time to update their program descriptions. At this meeting three agencies were approved for funding as they provided necessary services to low-income residents in the midst of the pandemic. Those agencies were Health Care Consumers, Sola Gratia, and Wesley Food Pantry.

Four agencies provided updates to their programs due to changes resulting from COVID-19. Agencies denied for funding had incomplete applications, were part of a taxing body, or not did meet immediate needs of low-income residents. Most programs were still operational, despite the pandemic. Programs providing meals and services to immigrants were prioritized during the review process. Attached is the scoring tool used to assess applications upon the same metrics.

Agencies funded by the City of Urbana will be reimbursed using a fee for service model. This ensures tax payer dollars directly support residents, even if agencies serve clients across Champaign County.

Anticipated Fiscal Impacts

Funds for this program have previously been set aside and approved by Council and Town Board. A total of \$175,000 from three funding sources will support this year's program. General funds will provide \$70,000; CDBG funds will provide \$5,000; and Cunningham Township Supervisor's Office (CTSO) will provide \$100,000. There will be no additional fiscal impacts on the City.

Recommendation

The CSSF Committee recommends funding the agencies listed below at the suggested amounts.

*Services needed by extremely low-income residents:

- Accessing homeless support and shelters
- Accessing DHS services (LINK/TANF/Medicaid)
- Applying for SSI/SSDI (SOAR)
- Accessing health care services/specialists/dentists/eye care
- Mental health evaluations/therapy

- Substance abuse support
- Overcoming barriers based on criminal convictions
- Accessing personal assistants
- Bus passes/transportation support
- Youth programs
- Employment programs, workforce development, job creation
