SUBJECT: An Ordinance Fixing the Salary of City Officers Who are Elected for a Definite Term of

Office

Introduction: The Urbana City Council sets the salaries of the City's elected officers. The attached proposed Ordinance would fix the salaries of the City's elected officers for the quadrennial from May 1, 2021 through April 30, 2025.

Discussion: The salaries proposed in the attached Ordinance (summarized below) reflect a one percent increase over the current salary level in the first year of the quadrennial and successive one percent increases each year thereafter.

Notwithstanding the challenging financial situation currently being experienced by the City and elsewhere, the small salary increase I am proposing reflects a modest attempt to keep pace with inflation and to recognize the substantial personal time commitment required by these elected officers.

Recommendation: I recommend that City Council approve the attached Ordinance.

ORDINANCE NO. <u>2020-10-054</u>

AN ORDINANCE FIXING THE SALARY OF CITY OFFICERS WHO ARE ELECTED FOR A DEFINITE TERM OF OFFICE (2021-2024)

WHEREAS, the City of Urbana ("City") is a home rule unit of local government pursuant to Article VII, Section 6, of the Illinois Constitution, 1970, and may exercise any power and perform any function pertaining to its government and affairs, including the power to regulate for the protection of the public health, safety, and welfare; and

WHEREAS, the corporate authorities of a municipality may, in an ordinance, fix the salaries of all officers who hold elective office for a definite term in accordance with 65 ILCS 5/3.1-50-10; and

WHEREAS, the Mayor, City Clerk, and Alderpersons of the City of Urbana are all elected for definite terms; and

WHEREAS, from time to time, the City of Urbana elects to adjust the salaries of its elected officers and must do so within a specific, statutory timeframe.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Urbana, Champaign County, Illinois, as follows:

Section 1.

The annual (12 month) salary of the following city officers who are to be elected for a definite term beginning in May 2021, shall be and the same are hereby established for that and subsequent terms of office, as follows:
