The City Council of the City of Urbana, Illinois, met in regular session Monday, October 26, 2020, at 7:00pm via Zoom.

A. Call to Order and Roll Call

With a quorum virtually present, Mayor Marlin called the meeting of the Committee of the Whole to order at 7:00pm.

e. Ordinance No. 2020-10-057: An Ordinance Amending Certain Urbana City Code Sections (To Reflect Changes in Laws Governing Cannabis and Cannabis Paraphernalia Use and Possession)

Mayor Marlin and City Attorney James Simon responded to questions about the aggravated nuisance ordinance and the responsibility of landlords, saying it has been used very few times. Attorney Simon said this is not used to evict tenants, but is more for concentrated areas of crime, and gives the landlords an opportunity to come to the City to address problems.

g. Ordinance No. 2020-10-056: An Ordinance Revising the Annual Budget Ordinance (Budget Amendment #3 – Omnibus)

Mayor Marlin explained \$6,885 in police expense is for very thorough triennial physicals for police officers.

The \$250,000 for parking meter replacement was questioned. City Administrator Carol Mitten said it was to replace parking meters. It had been planned for the previous year but there was not enough manpower to do it. She added the City is expecting a significant loss in parking revenue because they had not been charging for parking. Now that they are charging for parking, utilization is down. There was further discussion about the amount of money in the parking fund.

CM Wu made a motion to amend Ordinance No. 2020-10-056 by removing the meter infrastructure project for \$250,000 for consideration at another date. Motion seconded by CM Miller and carried by roll call vote as follows:

h. Resolution No. 2020-10-052R: A Resolution Declaring Continued Utility Disconnections in Illinois to be a Pandemic Safety Risk

CM Hursey moved to approve Resolution No. 2020-10-052R. Motion seconded by CM Miller.

CM Miller suggested the possibility of having the utility companies give the City notice when they are planning to issue disconnect notices to Urbana residents.

Mayor Marlin said she would give a copy of this resolution to the governor. She said Ameren and American Water have voluntarily agreed to suspend shut-offs until March 31, 2021. Extensive discussion about utility shut-offs and homelessness ensued. City Attorney Simon said it would be a good idea to get copies of the agreements from the Illinois Commerce Commission Ameren and Illinois Water to see if they have payment plan issues.

H. Reports of Officers

City Administrator Mitten informed council members about the <u>Use of Force policy revision and listening sessions</u> and gave an <u>email address</u> to which people can send suggestions. Deputy Police Chief Richard Surles was present and answered questions from council members.

I. New Business

1. <u>Resolution No. 2020-10-053R</u>: A Resolution Accepting an Illinois American Water Firefighter Grant from Illinois American Water

City Administrator Mitten addressed this resolution. She said the grant is for \$1,000 and will be used to purchase a roof training prop.

CM Wu made a motion to pass Resolution No. 2020-10-053R, which was seconded by CM Miller and carried by roll call vote as follows:

2. <u>Resolution No. 2020-10-054R</u>: A Resolution of Support for an Application for Illinois Transportation Enhancement Funds (Bakers Lane Shared-Use Path)

City Administrator Mitten presented this resolution and said this is a right-of-way that goes along the east of Weaver Park between Main Street and Washington Street and would provide bicycle and pedestrian facilities that would connect Dr. Williams Elementary School, the Kickapoo Rail Trail, offices at the Brookens Building and several neighborhoods. She made a correction to the estimated total project cost, which will be \$249,877.50. Urbana's share would be \$49,977.50. There will also be a section added to the resolution which would be worded, "Whereas the City of Urbana will provide the financial commitment up to 20% of the total project cost as requested from the State of Illinois to construct this shared-use path".

After discussion CM Brown moved to approve Resolution No. 2020-10-054R. Motion seconded by CM Hursey and carried by roll call vote as follows:

3. <u>Discussion</u> – CPRB Status Report and Recommendation

City Administrator Carol Mitten began this discussion with statistics, saying there has been a dramatic increase in police complaints in 2020. In the previous 10 years the average for police complaints was nine per year, and the amount for 2020 is 10 times that number. She said the increase in complaints is being driven by a single complainant and the number submitted by that complainant year to date is 86% of the complaints filed. There has also been an increase in appeals in 2020, with 60 appeals on 92 complaints and 97% of appeals were submitted by one appellant. She said the problem with the Civilian Police Review Board (CPRB) complaint and appeal process is the CPRB ordinance does not define the type of misconduct that would warrant a complaint, and gave examples from some cities that do define it. Administrator Mitten said administrative/procedural complaints and car/minor operational complaints comprise 89% of the appeals, and gave a breakdown on average of staff time and expense per appeal.

CPRB members Ricardo Diaz and Scott Dossett were present and commented on the lack of guidance in types of complaints and appeals, and the poor performance of the CPRB in the past. Amending the ordinance to reflect a complaint and appeal process was discussed.

At 10:26pm CM Wu moved to extend the meeting to 10:45pm. Motion seconded by CM Hursey and carried by roll call vote as follows:

Extensive discussion ensued. Ricardo Diaz said no complaints should be ignored, but there should be a filtering process to decide who will take care of complaints concerning administrative or minor operational issues.
