#### Introduction

In 2009<sup>1</sup>, and again in 2015<sup>2</sup>, the City of Urbana adopted the Champaign County Multi-Jurisdictional Natural Hazard Mitigation Plan (HMP) and amended the City of Urbana Comprehensive Plan to include the HMP as an amendment of the City's Comprehensive Plan. City staff now requests that the City Council review and adopt the new five-year update to the HMP, which would supersede the 2015 version.

The HMP update was prepared by Champaign County Regional Planning Commission staff. The final draft of the 2020 Hazard Mitigation Plan is available online at: http://champaigncountyhmp.info/.

At the April 22, 2021, meeting, the Plan Commission voted unanimously with seven ayes and zero nays to forward the Champaign County Multi-Jurisdictional Hazard Mitigation Plan 2020 Update to City Council with a recommendation of approval.

# Background

The Urbana City Council has participated in regular updates of the HMP since 2008. By participating in the HMP update process and by adopting the updated HMP, the City continues in good standing to be eligible for federal and state mitigation project grant funding, and Urbana residents remain eligible for lower flood insurance premiums, as well as other potential benefits.

#### Purpose of the HMP

The HMP is intended to meet the planning requirements of the Disaster Mitigation Act of 2000, as administered by the Federal Emergency Management Agency (FEMA).

#### **HMP Update Process**

The HMP update process included four major stages, with opportunities for public participation throughout: 1) organizing resources; 2) assessing risks; 3) developing the mitigation plan; and 4) implementing the plan

and monitoring progress.

The existing HMP was adopted by Champaign County and by each participating local government in 2015. In July 2019, the Illinois Emergency Management Agency (IEMA) and Champaign County entered into an agreement to develop an updated HMP for FEMA review and approval.

In total, 27 jurisdictions, including the City of Urbana, participated in the HMP update process. The Planning Team included municipal planners, public safety planners, and emergency responder representatives who guided the HMP update and provided key input. City of Urbana Public Works Sustainability & Resilience Officer Scott Tess and City of Urbana Fire Department Division Chief Kyle Hensch represented Urbana on the Planning Team.

A broad-based HMP Advisory Group supported the Planning Team in their review of the draft HMP update and provided review comments. The HMP Advisory Group included representatives of key area-wide public and private service providers, and selected government agency representatives.

The Planning Team selected the following types of natural hazards identified in the 2018 Illinois Natural Hazards Mitigation Plan and the 2014 Illinois Department of Public Health Pandemic Influenza Preparedness and Response Plan to include in the HMP update:

Severe Storms

Tornadoes

Severe Winter Storms

Floods

Extreme Heat

Earthquakes

Drought

Pandemic

Based on recommendations by the Champaign County EMA Manager and HMP project staff, the Planning Team selected the following human-caused hazards or threats to include in the HMP:

Hazardous Material Storage and Transport Release or Spill

Active Shooter

Cyberattack

The HMP update features an assessment of community capability to address the selected hazards and threats, and a risk assessment for the selected hazards and threats. The Planning Team reviewed and proposed hazard mitigation actions for the selected hazards and threats. The HMP update includes prioritized hazard mitigation actions specific to the City of Urbana, detailed in Exhibit A.

#### FEMA and IEMA Review of HMP Update

FEMA Region V and IEMA staff completed their review of the final draft of the HMP update on November 24, 2020 and provided notification that the update meets required criteria for a multi-jurisdictional hazard mitigation plan.

Formal approval of the HMP update is contingent upon adoption by the participating jurisdictions of the HMP Update. FEMA Region V received documentation of adoption from the first of 27 participating jurisdictions on December 7, 2020. As a result, FEMA will provide a FEMA letter of official approval of the HMP Update, with the HMP Update to have an expiration date in December 2025.

FEMA offers communities mitigation grant funds whenever there is a Presidential disaster declaration in the state. Such grant funds may be used for projects like acquiring flood-prone properties, constructing safe rooms to protect people from tornadoes, and installing measures to prevent storm water from flowing into sanitary sewer lines and backing up into basements. The Federal Disaster Mitigation Act of 2000 requires that local jurisdictions have a hazard mitigation plan prior to receiving hazard mitigation funds.

FEMA defines hazard mitigation plans as: "any sustained action to reduce or eliminate the long-term risk to human life and property from hazards." As opposed to emergency response plans, hazard mitigation plans are intended as policies to encourage or require actions that can be taken ahead of time to lessen the adverse impacts of a natural or technical hazard.

## 2005 City of Urbana Comprehensive Plan

Staff proposes that the City adopt the 2020 Hazard Mitigation Plan Update as an amendment of 2005 Urbana Comprehensive Plan. The 2020 HMP will replace and supersede the 2015 HMP. The Comprehensive Plan (as amended) includes the following goals, objectives, and implementation items significant to the proposed HMP Update:

#### Goals and Objectives

Goal 7.0 Protect and beautify existing waterways.

**Objectives** 

- 7.1 Protect the floodway of the Boneyard Creek.
- 7.2 Ensure that development regulations protect floodways and major drainageways.
- 7.3 Redevelop parts of Boneyard Creek to provide natural and public amenities.

Goal 8.0 Minimize the impact of natural and man-made disasters.

**Objectives** 

- 8.1 Promote construction that reduces the effects of high winds, ice storms, flooding, etc.
- 8.2 Prepare necessary disaster preparedness measures in order to best protect the community from disasters.

Goal 33.0 Provide maximum service and dependable utilities.

**Objectives** 

33.2 Correct areas of storm water infiltration-inflow into the sanitary sewer system.

Goal 36.0 Protect both developed and undeveloped areas from increases in runoff and localized flooding. Objectives

- 36.1 Protect life and property from storm and floodwater damage.
- 36.2 Reduce the impacts of development on stormwater conditions through regulations, including appropriate provisions for detention and conveyance.

#### Comprehensive Plan Implementation Strategies

• Adopt a Hazard Mitigation Plan that offers strategies for reducing the effect of natural disasters. Timing: Near Term

• Explore grants and incentives that can be used to encourage relocating existing and future utilities underground.

#### Discussion

Taking a county-wide approach to hazard mitigation planning includes some important benefits, including:

- Allowing participating local government jurisdictions to become eligible for Federal hazard mitigation funds, in conformance with the Disaster Mitigation Act of 2000;
- Enabling coordinated approaches to mitigate hazards across jurisdictions;
- Allowing cost savings by sharing resources and using economies of scale; and
- Avoiding duplication and ensuring consistencies where appropriate.

In terms of fiscal impacts to the City, there will be some costs incurred to fully comply with the plan, but plan adoption will also reduce the costs associated with any future disasters and make the City eligible to apply for hazard mitigation grant funds to both prevent and respond to disasters. In prioritizing the action items, the relative cost versus risk and benefit was taken into account.

#### **Plan Commission**

On April 22, 2021, the Plan Commission discussed the proposed Champaign County Multi-Jurisdictional Hazard Mitigation Plan Update. The Champaign County Department of Planning and Zoning (CCDPZ) prepared a presentation about the update to the plan. Susan Monte of CCDPZ explained that the Hazard Mitigation Plan is updated every five years, to keep the City current and eligible for certain benefits. Local governments are required to address natural hazards, and most hazard mitigation plans also address manmade hazards. This plan relies on data from local municipalities, FEMA, and the Illinois State Water Survey. The Plan Commission discussed the 100-year flood line and FEMA map referenced by the plan. They also discussed the transfer of development rights in the Boneyard Creek. The Plan Commission then voted unanimously with seven ayes and zero nays to forward the proposed Champaign County Multi-Jurisdictional Hazard Mitigation Plan 2020 Update to City Council with a recommendation to approve the plan as presented and adopt it as an amendment to the 2005 Urbana Comprehensive Plan (as amended). Draft minutes are found in Exhibit C.

# **Summary of Staff Findings**

- 1. The proposed Final Draft of the Champaign County Multi-Jurisdictional Hazard Mitigation Plan Update was prepared pursuant to the Disaster Mitigation Act of 2000 and is consistent with the National Mitigation Strategy developed by the Federal Emergency Management Agency (FEMA). The content of the proposed HMP Update was reviewed by FEMA and by the Illinois Emergency Management Agency and has been determined to meet the required FEMA criteria.
- 2. The proposed Champaign County Multi-Jurisdictional Hazard Mitigation Plan Update supersedes and acts as an update to the 2015 HMP adopted by the City of Urbana.
- 3. Adoption of the proposed HMP Update by the City of Urbana will better prepare the City to be eligible to receive funding assistance from FEMA in the event of a disaster. Adoption of the proposed HMP Update will also allow the City to pursue pre-disaster mitigation funds.
- 4. Adoption of the proposed HMP Update as an amendment of the Comprehensive plan is consistent with Urbana Comprehensive Plan goals, objectives, and implementation strategies.

# **Options**

The City Council has the following options:

- 1. Approve the ordinance, adopting the HMP as an amendment of the Urbana Comprehensive Plan; or
- 2. Approve the ordinance with specific changes; or
- 3. Do not approve the ordinance and risk not being eligible for hazard mitigation funds.

#### Recommendation

At its April 22, 2021, meeting, the Plan Commission voted unanimously to recommend City Council **ADOPT** the plan as an amendment of the 2005 Urbana Comprehensive Plan, as amended.

Staff concurs with this recommendation and suggests placement of the item on the consent agenda.

# AN ORDINANCE AMENDING THE 2005 COMPREHENSIVE PLAN OF THE CITY OF URBANA, ILLINOIS

(Champaign County Multi-Jurisdictional Hazard Mitigation Plan 2020 Update/ Plan Case 2419-CP-21)

**WHEREAS,** the Urbana City Council on April 11, 2005 in Ordinance No. 2005-03-050 adopted the Comprehensive Plan 2005; and

**WHEREAS,** the Comprehensive Plan 2005 (as amended) contains goals, objectives, policies, and other recommendations pertaining to land uses, housing, neighborhoods and public infrastructure in the community; and

WHEREAS, the U.S. Government in 2000 adopted the Disaster Mitigation Act, with Hazard Mitigation Planning rules following in 2002 as part of the Code of Federal Regulations; and WHEREAS, pursuant to the Disaster Mitigation Act, preparation of a Hazard Mitigation Plan allows communities to be eligible for mitigation grant funds and pre-disaster mitigation grants; and

**WHEREAS,** The Federal Disaster Mitigation Act of 2000 introduced legislation that reinforces the importance of pre-disaster infrastructure mitigation planning to reduce disaster losses nationwide; and

WHEREAS, An approved local mitigation plan that addresses the specific natural and manmade hazard threats to local jurisdictions makes jurisdictions eligible to apply for mitigation funding through the following Federal Emergency Management Agency programs: Pre-Disaster Mitigation Program, Hazard Mitigation Grant Program, Flood Mitigation Assistance; and

**WHEREAS,** Urbana's Hazard Mitigation Plan was adopted by the Urbana City Council on June 20, 2005 by Ordinance No. 2005-06-087; and

**WHEREAS,** the Champaign County Multi-Jurisdictional Hazard Mitigation Plan was adopted as an amendment to the Comprehensive Plan by the Urbana City Council on August 17, 2009, by Ordinance No . 2009-08-90 and updated and replaced the 2005 Plan;

**WHEREAS,** the Champaign County Multi-Jurisdictional Hazard Mitigation Plan Update was adopted as an amendment to the Comprehensive Plan by the Urbana City Council on September 21, 2015, by Ordinance No. 2015-09-100 and updated and replaced the 2009 Plan; and

WHEREAS, The Champaign County Multi-Jurisdictional Hazard Mitigation Plan is intended to meet the planning requirements established in the Disaster Mitigation Act of 2000; and

**WHEREAS,** the Champaign County Multi-Jurisdictional Hazard Mitigation Plan recommends updating the Plan every five years; and

WHEREAS, the City of Urbana participated in and contributed towards a multijurisdictional effort to review and update the Hazard Mitigation Plan to address new hazards and include new action items; and

WHEREAS, after due publication and proper legal notification of a public hearing on April 22, 2021, the Urbana Plan Commission in Plan Case 2419-CP-21 has recommended the adoption of the Champaign County Multi-Jurisdictional Hazard Mitigation Plan 2020 Update by a vote of seven to zero; and

WHEREAS, the City Council finds that it is in the public interest to amend the 2005

Comprehensive Plan (as amended) to incorporate the findings and recommendations contained in the Champaign County Multi-Jurisdictional Hazard Mitigation Plan 2020 Update; and

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Urbana, Illinois, as follows:

# HMP Update Excerpt: Primary Hazards of Concern and Prioritized Hazard Mitigation Actions for Urbana Exhibit A

Table 5-50: Primary Hazards of Concern to City of Urbana

1	Due to changing climate conditions over the next several years, the City of Urbana can expect to experience more frequent episodes of extreme precipitation, severe weather events, and extreme temperatures.
2	Flash flooding on paved impervious areas can occur due to more frequent extreme precipitation events.
3	Riverine flooding may be exacerbated in remaining unimproved portions of the Boneyard Creek drainage basin within City limits, and along McCullough Creek, which flows through southern Urbana before joining the Embarras River and is known to experience overbank flooding as a result of short, intense thunderstorms
4	The main threats posed by severe winter storms will be injuries or deaths from dangerously low temperatures and accidents, injuries, or fatalities from hazardous driving conditions, and severe tree damage.
5	Certain natural hazards (e.g., tornado or earthquake) may occur with little or no warning.
6	The unknown and unpredictable aspects of potential human-caused hazards (i.e., active shooter, cyberattack, or hazardous materials storage/transport release or spill) will continue.

#### **NEW PUBLIC HEARINGS**

Plan Case No. 2419-CP-21 – A request by the Urbana Zoning Administrator to adopt the Champaign County Multi-Jurisdictional Hazard Mitigation Plan 2020 Update as an amendment to the 2005 Urbana Comprehensive Plan (as amended).

Chair Fitch opened the public hearing for Plan Case No. 2419-CP-21. Kevin Garcia, Principal Planner, presented the staff report to the Plan Commission. He began by explaining the purpose of the amendment, which is to allow the adoption of the new five-year update to the Hazard Mitigation Plan (HMP). He introduced Susan Monte, Planner at Champaign County Planning and Zoning.

Ms. Monte spoke to the Plan Commission and talked about the process for updating the HMP. She noted that updating the plan is important to keep the City of Urbana current and eligible for

certain benefits. Local governments are required to address natural hazards such as tornados, flooding and severe thunderstorms. Most hazard mitigation plans also address man-made hazards. She shared a HAZUS model map showing the City of Urbana for the 100-year floodplain. The map shows buildings that could sustain damage. She stated that all of the hazard mitigation actions that were identified in the 2015 update were carefully examined and updated in the proposed amendment. She asked if any of the commission members had questions.

Mr. Fell noted that the Federal Emergency Management Agency (FEMA) map is notoriously incorrect in its location of the 100-year floodplain. Do we use local survey information to establish the 100-year floodplain or do we rely on the FEMA map? Ms. Monte answered saying that the HMP relies on information collected by FEMA, the Illinois State Water Survey, the Illinois Floodplain maps and from local information as well. If there is a question about the 100-year floodplain boundary, there is a process in place that a person could challenge it. The 100-year Floodplain Map was updated in 2013.

Mr. Hopkins asked if the actions marked as "New" in the Status column indicated new actions that were not in the 2015 HMP amendment. Ms. Monte confirmed this. She noted that Appendix M shows the difference between the actions approved in 2015 and the new ones added for the proposed amendment. Mr. Hopkins stated that the "new" actions are the ones that the Plan Commission and City Council should focus on to make sure that the City should do them.

Mr. Hopkins asked what "Pending" in the Status column meant and what "Recommended for inclusion in a future list of capital projects" means. He felt Table 5-51: Prioritized Hazard Mitigation Actions for City of Urbana was important for the City Council to recognize that some people may consider this list to be actions that the City is committing to do. Ms. Monte recalled that "Pending" was assigned to new actions added in the 2015 amendment. Though those actions are not "new" in the proposed amendment, they are still pending.

Mr. Hopkins questioned the Transfer of Development Rights in the Boneyard Creekway. He was not aware of the City having this. Mr. Garcia confirmed that there is a small Transfer of Development rights for properties that are partially in the floodplain; however, he did not believe it had ever been used.

With there being no further questions for City or Champaign County staff, Chair Fitch opened the hearing for public input. There was none, so Chair Fitch closed the public input portion of the hearing. He then opened the hearing for Plan Commission discussion and/or motion(s).

Mr. Allred commented that the timing for updating the Hazard Mitigation Plan is perfect because the City of Urbana is in the process of updating the Comprehensive Plan. It will not only be adopted as an amendment to the existing Comprehensive Plan but will also have an impact on the content updated in the Comprehensive Plan.

Ms. Billman moved that the Plan Commission forward Case No. 2419-CP-21 to the Urbana City Council with a recommendation for approval. Mr. Allred seconded the motion.

Mr. Hopkins expressed confusion about whether they would be adopting an "element", making an amendment, replacing an amendment, or replacing an element. With updating the Comprehensive Plan, it would be nice to have the wording be consistent. Chair Fitch stated that staff's recommendation suggested the City adopt the plan as an element of the 2005 Urbana Comprehensive Plan, as amended. Mr. Hopkins suggested adding language to say that the proposed amendment replaces the 2015 Hazard Mitigation Plan. Mr. Garcia recommended using the term "amendment" rather than "element".

The motion was that the Plan Commission forward Plan Case No. 2419-CP-21 to the City Council with a recommendation for approval of replacing the 2015 Champaign County Multi-Jurisdictional Hazard Mitigation Plan with the proposed plan as an amendment to the 2005 Urbana Comprehensive Plan. Roll call on the motion was as follows:

The motion passed by unanimous vote.

Mr. Ricci noted that Plan Case No. 2419-CP-21 would be forwarded to the Committee of the Whole on May 3, 2021.
