Public Input

Brandy McCoy expressed concerns about the CPRB and policing in the community , *Allan Max Axellrod* spoke in support of SWFT program, *Sarah Nixon* spoke in support of a hybrid meeting model and encouraged the council to make public input as accessible as possible. *Tracy Chong*, *Rev. Dr. Evelyn Underwood* via written input and read by CM Hursey "I, Rev. Dr. Evelyn underwood and Bishop King James Underwood, support the SWFT program which provides short-term (one year or less) training in more than 20 career options that leads to employment in in-demand fields with life-supporting wages. Besides tuition and fee waivers to take classes, one may receive assistance in the form of a stipend. I believe this can help families tremendously! Please fully fund this program for Urbana residents or enter into an intergovernmental agreement with the City of Champaign and Champaign County Board."
