The completed job description will be reviewed for approval at the next scheduled commission meeting.

## B. Fire Fighter Hiring Rules

Staff provided Commission with a draft of Fire Fighter Hiring Rules. After discussion, Commissioner Broom moved and Commissioner Knight seconded approval.

## C. Approval of Fire Fighter job posting

Staff provided Commission with a draft of Fire Fighter Job Posting. After a discussion, Commissioner Broom moved and Commissioner Knight seconded approval.

## D. Approval of Fire Fighter job description

Staff provided Commission with a draft of Fire Fighter Job Description. After a discussion and some minor revisions, Commissioner Broom moved and Commissioner Knight seconded approval.

# E. <u>Re-schedule April Meeting</u>

Staff requested re-scheduling the April meeting due to the timing of a scheduled exam in April. There would not be adequate time before the meeting to establish a passing score and register. The commissioners agreed on May 2<sup>nd</sup> at 10:00 a.m. for the new date and time.
