		<p><b>Consolidated Social Service Funding:</b></p> <ul style="list-style-type: none"> <li>• Funding pool consists of Cunningham Township Funds, City of Urbana General Funds, and CDBG Public Service Funds.</li> <li>• No more than 15% of any year's CDBG allocation may be used to fund social service programs.</li> <li>• Applications available (Monday, March 12, 2007)</li> <li>• Applications due (Friday, April 13, 2007) (April 6 is city holiday)</li> <li>• City Council determines date &amp; time of presentations</li> <li>• City Council determines which agencies get funding and how much</li> <li>• AAP must be amended to include agencies &amp; amount of CDBG funding under public service</li> <li>• To amend AAP need a display ad in N-G, mail notice to media, 30 day public comment period, and public hearing. Send amendment to HUD.</li> </ul>
