- Set up and closed out various activities for the City of Champaign in the federal Integrated Disbursements and Information System (IDIS).
- Drew down federal funds to reimburse eligible expenses related to HOME program activities
- Drafted Homebuyer Program agreement now required by HUD for use with all downpayment activities funded by HOME Program allocations.

- Emergency Grant /Access Grant projects to date: No applications

• FY 13-14 Rehab Projects

- Emergency Grant /Access Grant projects to date: 11 applications have been taken, 10 projects completed, 1 still in progress.
- Senior Repair Service Projects to date: 15 applications have been taken and are complete.
- Whole House Rehabilitation Projects to date: 6 applications have been taken and approved; 4 are complete and 2 are in progress.

• FY 14-15 Rehab Projects

- Currently taking applications for participation in the Whole House Rehabilitation Program.
- In process of closing last fiscal year projects and processing new applicants for new fiscal year projects pending release of funds.
- Coordinating efforts with Building Safety and other City Departments for the demolition of the Urbana Townhomes bids have been received demo pending environmental review process.
- Completed bid proposals for demolition of 301 Thompson and bids received, demo pending permit.
- Coordinating efforts for Barnes Mobile Home Park resident relocation.
- Monitoring TH Rehab project.
