## MINUTES

### **OLD BUSINESS**

Ron Eldridge distributed Fire Pension Fund Investment Data Sheets dated January 19, 1993.

Ron Eldridge stated that he needs to meet with Fritchey and McDuffy to completed the cash flow report.

### **NEW BUSINESS**

President Harmon stated that Assistant City Attorney Lindsey had no further information on HIV-Testing for new hires. Attorney Lindsey will research the recent decision on the Washington DC Fire Department case.

President Harmon reported that Donald Babbs received \$5,363.29, and Raymond Johnson received \$6,539.17 (4% pension adjustment from 76/77 salary increase). Doyle Skinner received 3.75% retroactive pay for 92/93 salary increase. Donald Harvey received no retroactive pay for 92/93 salary increase because he was on unpaid leave. President Harmon stated that Harvey retroactive pay may be reevaluated if his workers comp. litigation is finalized.

President Harmon stated that on January 19, 1993, he talked to the Department of Insurance reference ADA's requirements for employees physicals to be maintained by the City. President Harmon was told that the City and Pension Board are two different entities, and if the Department of Insurance audited our files and the physical reports were not present, the Board would be in violation and could be fined for up to \$1,000 per day the files are absent from the files.

President Harmon stated that he informed the U.S. Department of Justice of our meeting today and they stated they did not need to meet with the Board, since the information we sent them contained all the required information.

President Harmon stated that he received a letter from Assistant City Attorney Tom Lindsey stating that the Board would have to acquire outside legal representation for any Board litigation.

Presented Harmon announced that the general department meeting to elect members for the Board is April 19, 1993. Lt. Harmon's term expires and Firefighter Eichorn has indicated he will resign his position.

Firefighter McDuffy stated that he would like to purchase a computerized check program. Ron Eldridge stated that he has a new QUICKEN Program that he Board could have.

The Fire Department Pension Board of Trustees meeting was held on Wednesday, April 21, 1993, in the Urbana City Building. President Harmon called the meeting to order at 10:07 a.m.

### ADA REQUIREMENTS

Ron Gremore stated that the City cannot do a medical examination on a new hire and later make the offer based on the medical results. The offer must be made first, conditional on passing the medical Ron also stated that for the last two (2) years the City have been doing a Psychological assessment on candidates. as the employer, has (verbally) accepted the medical findings from the Pension Board, however, under the ADA Ron isn't sure the City can continue to do this, because the City (through his office) has no record of the medical condition of that person. Ron Gremore proposed to use one (1) pre-employment examination to determine Pension eligibility and employment, split the cost, and have the the results sent to both the City and the Pension Board. Gremore stated that it is his understanding that under the ADA the City of Urbana is required to keep the medical records since the information is used to determine employment. Ron also stated that the Pension eligibility criteria might be different from the City. For example, based upon the court decisions Ron has seen, the City cannot use HIV Testing as a basis not to hire. If the Board decided to test for AIDS, the City would not received a copy of that report, and the Pension Board would pay for the AIDS test. Ron presented the Board with a list of tests for new hire. attached) Gremore would like to use this list to establish rates for FY 93/94.

Lt. Harmon stated that the Board met with Dr. Main and determined what tests should be done on pre-employment physical examination. Lt. Harmon stated that the Board would have to seek legal advise on Drug Use, HIV Testing and ADA Requirements.

Ron Gremore stated that medical records for current firefighters should be placed in their Personnel file. After discussion, Ron suggested that a cover sheet on current firefighters where the doctor states that he/she is medically fit to go to work for the City of Urbana, based upon said standards.

Firefighter Rose asked Ron Gremore:

1) How does the ADA apply to current employees because the ADA was not in existence then?

Ron Gremore stated that the ADA covers current and future employees.

2) Would claustrophobia (a psychological handicap) prevent you from hiring someone and HIV wouldn't?

Ron Gremore stated that's a possibility because claustrophobia can be validated.

Acting Chief Dunn stated that he would not hire someone with acrophobia who could not climb a ladder, but if someone develops acrophobia ten (10) years later is another issue.

Ron Gremore stated that it is a matter of degrees and we would have to refer to the Psychologist opinion as to whether he/she could do the job.

## Board discussion after Ron Gremore left:

President Harmon moved that if we decide to share pre-employment medical records, that we come to a consensus on what to test for new hires, and a medical cover sheet on current employees, only if Board's independent legal advisor says there is no repercussion. The motion was seconded by Chief Dunn and carried by a voice vote.

### MINUTES

Chief Dunn moved to approve the minutes dated October 20, 1992, January 20, 1993 and March 10, 1993, as corrected. The motion was seconded by F.F. McDuffy and carried by a voice vote.

## OLD BUSINESS

Ron Eldridge distributed Fire Pension Fund Investment Data Sheets dated April 19, 1993. Ron stated that we had two (2) CD's which matured (April 16th and 17th, 1993) and was rolled over for one (1) year.

President Harmon turned over a memo from Tom Lindsey's research assistant to F.F. McDuffy reference HIV-Drug Testing for new hires.

F.F. McDuffy stated that he did some checking with DELUXE and moved to purchase 1,000 computerized checks for \$100, to be used with Quicken Version 6 Program. The motion was seconded by Charles Glenn and carried by a voice vote.

## **NEW BUSINESS**

President Harmon read a letter he wrote to the Illinois Department of Insurance on March 16, 1993, reference Holiday Pay. He received a reply from Mr. Tom Jones (very efficient) on March 27, 1992, stating that if the firefighters do not have a choice of pay or compensatory time, pension contribution must be deducted from Holiday Pay.

Effective July 1, 1993, pension contribution will be deducted from Holiday Pay, and Holiday Pay will be added to your salary upon retirement.

President Harmon stated that if a decision is made to share pre-employment cost with the City, the Medical Release Form should include both the City of Urbana Personnel Department and Urbana Fire Department Pension Board. The consensus of the Board was to ask our independent legal advisor.

President Harmon stated that two firefighters have picked up Pension Applications. Robert E. Ebeling returned his and applied for Duty Disability under Heart/Lung Section of the Pension Code, and Firefighter Kenneth J. Frantz is applying for normal retirement. 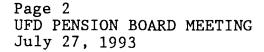
