The Fire Department Pension Board of Trustees meeting was held on Wednesday, March 16, 1994, in the Urbana City Building. President Glenn called the meeting to order at 10:10 a.m.

# MINUTES

The minutes for July 27, 1993 and September 9, 1993, were postponed until the next meeting.

## TREASURER'S REPORTS

Chief Dunn moved to approve the treasurer's reports, as amended with date change, dated July 1993, August 1993, September 1993, October 1993, November 1993, December 1993, January 1994 and February 1994. The motion was seconded by F.F. Rose and carried by a voice vote.

A quarterly report will be created by Eldridge and McDuffy before the next meeting.

Ron Eldridge gave a brief summary of the City of Urbana, Illinois, Firemen's Pension Fund Audit Report for the Years Ending June 30, 1993 and 1992. Ron stated the auditors did not find any weaknesses in our accounting procedure.

#### OLD BUSINESS

## NEW BUSINESS

F.F. McDuffy called for discussion of F.F. Dotson's pension application for entrance in the pension fund. Based on a letter from Lee L. Woods, Compliance Officer, Public Pension Division, State of Illinois Department of Insurance, to enforce Section 4-107(b)(1) of the Pension Code could be a violation of the Age Discrimination in Employment Act.

After discussion it was moved by Ron Eldridge to contact the Firm (Cornfield & Feldman) out of Chicago and ask for advise in this matter if the cost is less then \$2,000. The motion was seconded by Rose and carried by a voice vote. McDuffy will contact the Firm.

The State of Illinois does not collect taxes on pension, therefore, the Urbana Pension Board will not withhold state tax for pensioners.

## MISCELLANEOUS

Chief Dunn stated that there is no vision requirement for new hires. The Board decided to give Ron Gremore the NFPA Standard to consider incorporating into the City Physical.

There being no other business to come before the Board, F.F. McDuffy moved to adjourn. The motion was seconded by Rose and the meeting adjourned at 11:55 a.m.

Dear Mr. McDuffy,

This is in response to your letter of September 14, 1993 regarding the provisions of Section 4-107(b)(1) of the Pension Code. As the Attorney General has indicated the enforcement of this Section could be a violation of the Age Discrimination in Employment Act, the Department's policy on the ADEA and its effect on Section 4-107 is as follows:

The effective date of the ADEA for purposes of Article 4 of the Illinois Pension Code was October 16, 1992. As the law has no retroactive effect, the date of entry for firefighters who were hired on or before October 16, 1992 and denied membership in the pension fund because they were age 35 or older should be October 16, 1992.

If hired after October 16, 1992, the effective date of entry into the pension fund is the date of hire.

We would remind you that all other provisions of Section 4-107 must be followed when accepting new hires in to the Pension Fund.

The Fire Department Pension Board of Trustees held a Meeting on Wednesday, June 22, 1994, in the Urbana City Building. President Glenn called the meeting to order at 10:10 a.m.

#### MINUTES

F.F. Neal moved to accept the minutes for July 27, 1993, September 9, 1993 and March 16, 1994. The motion was seconded by F.F. Rose and carried by a voice vote.

#### TREASURER'S REPORT

F.F. Rose moved to accept the treasurer's reports, as corrected, dated March 1994, April 1994, and May 1994. The motion was seconded by F.F. Neal and carried by a voice vote.

## OLD\_BUSINESS

Ron Eldridge distributes investment reports sorted by type/institutional. Ron stated that the Board has received the first distribution of property tax, and we have approximately \$620,000 to invest. Ron did an Annual Cash Flow Analysis to year 2055. Ron suggested that we invest \$500,000 in a 15-20 year Page 2 UFD PENSION BOARD MEETING JUNE 22, 1994

treasury bill for probably 7.5%. Ron moved to add the following institutions on our list to purchase treasury bills:

Busey Bank Champaign National Bank Bank One Champaign-Urbana First of America Bank-Champaign

The motion was seconded by F.F. Rose and carried by a voice vote.

F.F. Rose stated that he would like to recommend to the Board to accept the City's psychological test results for new hires. After discussion the Board agreed to accept the City's psychological results, and remove this item from the agenda.

F.F. McDuffy stated that the age discrimination court case in Federal court is scheduled to be heard the first part of July, and the ruling will set a precedent for Dotson's pension application to be accepted in the Pension Fund. When the Federal court decision is published, the Board will resume this meeting.

F.F. Neal also stated that there is a bill before the Senate to reenact the firefighters exemption of the ADA, which would put into effect a age limitation for pension and new hire.

## NEW BUSINESS

The Board reviewed Jeffrey W. Ballew medical file cover letter from Dr. Main. Dr. Main stated that Jeffrey W. Ballew is in good health and is fit for duty as a firefighter, however, <u>LUMBAR SPINE: There</u> is slight posterior disc space narrowing at 4-5. I see no abnormality.

F.F. Neal moved to accept F.F. Ballew Pension application with the above underlined notation. The motion was seconded by F.F. McDuffy and carried by a voice vote. Ballew's date of hire is 05-01-94.

F.F. McDuffy read Retired Firefighter Tim Harvey's request to adjust his retirement date from 03-05-92 to 08-24-92, to reflect the pay increase of 07-01-92. After discussion, F.F. Rose moved to readjust Harvey's retirement date based on the Worker's Comp. decision, and report the date and amount at the next meeting. The motion was seconded by F.F. Neal and carried by a voice vote.

F.F. Rose moved to accept Assistant Chief Robert L. Pettyjohn's pension application for a regular pension, effective July 23, 1994, 0700 hours. The motion was seconded by F.F. Neal and carried by a voice vote.

## ELECTION OF OFFICERS

President Glenn opened the nomination for the 1994-95 Fiscal Year. F.F. McDuffy nominated F.F. Rose for Office of President. The motion was seconded by F.F. Neal. McDuffy moved that the nominations for the Office of President be closed. The motion was seconded by F.F. Neal and carried by a voice vote. A voice vote on the main motion to nominate F. F. Ricky P. Rose for Office of President for 1994/95 Fiscal Year carried unanimously.

F.F. Neal nominated F.F. Jeffery L. McDuffy for Office of Secretary/Clerk. The motion was seconded by F.F. Rose. Charles Glenn moved that the nominations for the Office of Secretary/Clerk be closed. The motion was seconded by F.F. Neal and carried by a voice vote. A voice vote on the main motion to nominate F.F. McDuffy for Office of Secretary/Clerk for 1994/95 Fiscal Year carried unanimously.

F.F. Neal moved to raise the Clerk's salary to \$325 a month, effective 7/1/94. The motion was seconded by Charles Glenn and carried by a voice vote.

F.F. McDuffy reported the results of the General Firefighter's Election held on Tuesday, June 21, 1994. F.F. Joel S. Neal was elected to a 3-year term to the Pension Board; voting aye (11), voting nay (0). His term will expire 6/30/97.

#### MISCELLANEOUS

F.F. McDuffy reported that F.F. Peggy L. Cook resigned from the Urbana Fire Department on April 26, 1994. The amount of pension contribution returned to her was \$1411.21, less 20% to be sent to the government.

There being no other business to come before the Board, F.F. Rose moved to recess the meeting. The motion was seconded by F.F. Neal and carried by a voice vote, and the meeting was recessed at 11:42 a.m.

PRESIDENT ROSE CALLED THE MEETING TO ORDER AT 10:12 A.M.

PRESIDENT ROSE BROUGHT TO THE BOARD THE FINAL DECISION ON JIMMIIE DOTSON APPLICATION INTO THE FUND. ROSE PRESENTED DOTSON'S PHYSICAL RESULTS FROM CARLE.
