A representative from First Busey Trust and Investment Inc returned to present their recommendations for our investment into the Stock Market.

First Busey Trust and Investment Inc. recommended that the Pension Fund invest in mutual funds. A written copy of their proposal is included with these minutes.

Motion By Comptroller Eldridge to adopt First Busey Trust and Investment Inc. as Urbana Fire Department Pension Board advisors and custodians.

Motion was seconded by City Clerk Clark.

Motion was carried by unanimous affirmative voice vote.

A motion was made by City Comptroller Eldridge to amend the current investment policy to incorporate those parts of the Illinois State Statutes allowing expanded investments, and to invest \$213,00.00 each month with First Busey Trust and Investment Inc. until the Pension Fund has reached the maximum allowable investment into stocks, (35%). The motion was seconded by City Clerk Clark.

Discussion

It was estimated that it would take just over two years to reach maximum investment.

The motion was carried by unanimous affirmative voice vote.

- 5. <u>Firefighter Troy Roberts</u> Hire date April 1, 1998. Comptroller Eldridge moved to accept Firefighter Roberts into the Pension. The motion was seconded by Sec/Clerk Rickords, carried by a voice vote and approved.
- 6. <u>Firefighter Gregory Smith</u> Hire date April 1, 1998. Comptroller Eldridge moved to accept Firefighter Smith into the Pension. The motion was seconded by FF Ballew, carried by a voice vote and approved.

(NEW BUSINESS CONTINUED)

B. DIRECT DEPOSIT

Sec/Clerk Rickords brought to the Board's attention past troubles with pensioners receiving their checks in a timely manner. According to his findings, it would be beneficial to switch from the current method of paying pensioners, either with individual checks or direct deposit, to ACH Deposit. Sec/Clerk revealed to the Board that, with the help of the City of Urbana's Accounting Department, this way of paying pensioners would have less margin of error and be more punctual. Comptroller Eldridge moved to implement the ACH Deposit. The motion was seconded by City Clerk Clark, carried by a voice vote and approved. Sec/Clerk Rickords will set up the process with a target start date of August 1, 1998.

OLD BUSINESS

- 1. Comptroller Eldridge handed out two documents. The first being titled "Agreement between the city of Urbana, Illinois Firefighter's Pension Fund and First Busey Trust and Investment Company." This document deals with concerning investment advising services. After some discussion, Sec/Clerk Rickords moved to accept this document as policy for the Board. - 2. The second handout from Comptroller Eldridge was titled "City of Urbana, Illinois Urbana Firefighter's Pension Fund: Statement of Investment Policy, Objectives and Guidelines." Comptroller Eldridge handed out draft copies of two pages of the <u>Firemen's Pension Fund</u>: 1. Comparative Statement of Net Assets as of June 30, 1998 and 1997, and 2. C. ACH Deposits

Sec/Clerk Rickords has designed a voucher that is to be sent to people who receive their money ACH. Also, Sec/Clerk Rickords is having an outside individual write a computer program to help with organizing and keeping track of payments to pensioners.

APPROVAL OF MINUTES

Firefighter Ballew moved to approve the minutes of the August 25, 1998 Fire Department Pension Board meeting. The motion was seconded by FF Wallace, carried by a voice vote and approved.

APPROVAL OF TREASURER'S REPORTS

Comptroller Eldridge stated that there was not a Treasurer's Report for approval.

Sec/Clerk Rickords handed out statements showing the activity of payments. FF Ballew moved to approve the Clerk's bills. The motion was seconded by President Harmon, carried by a voice vote and approved.

OLD BUSINESS

Pension Amounts

The Board discussed mistakes made in the pension amounts paid to Lt. Babbs and the widow of Lt. Johnson. This is the breakdown:

The Board discussed consistency in the way the future errors will be handled and decided it would be best to have a statement in writing regarding procedures.

President Harmon moved to: 1) make corrected payments to Lt. Babbs in the amount of \$2,815.35 and to the widow of Lt. Johnson in the amounts of \$3,191.48 and \$376.18, and 2) from this day forward, any honest errors the Board has made regarding pension amounts shall be paid to the pensioner plus interest at an accepted rate that is earned on a general bank savings account (currently 5%). The motion was seconded by Comptroller Eldridge, carried by a voice vote and approved.

*Amendment to minutes - Interest amounts were calculated by Comptroller Eldridge and will be paid as follows: Lt. Babbs will receive \$6,196.85 which reflects an interest rate of 5%, widow Johnson will receive \$6,896.65 which reflects a 5% interest rate (this interest is on the amount that should have been paid to Lt. Johnson), and widow Johnson will also receive \$9.42 which reflects a 5% interest rate (this interest is on the amount that should have been paid to her).

NEW BUSINESS

A. Updated *Department of Insurance / Article 4 / Firefighters' Pension Fund* booklets were copied and distributed to the Board Members. Copies will be made for all current and retired firefighters.

- **B.** <u>Firefighter Kyle Hensch</u> Hire date September 8, 1998. Comptroller Eldridge moved to accept Firefighter Hensch into the Pension. The motion was seconded by FF Ballew, carried by a voice vote and approved with three points of concern noted.
- C. Retired Firefighter Harry Jackson Retire date September 30, 1998. To receive a pension amount of \$27,545.47 equaling a monthly payment of \$2,295.46. President Harmon moved to accept this monthly payment to Jackson. The motion was seconded by FF Wallace and carried by a voice vote.
- D. Retired Firefighter Robert Pettyjohn To receive a 12% increase. Current monthly payment of \$2,624.88. This will increase to \$2,939.87 per month at the end of November 1998.
- E. <u>Tax Levy</u> Comptroller Eldridge stated that Actuary Tim Sharpe has reviewed the pension's numbers and suggested levy amount of \$399,157. The City has included this amount in their levy.
- F. Reimburse Sec/Clerk Rickords Sec/Clerk Rickords paid \$300 to have an outside person write and design a computer program to be used for accounting purposes for pension business. He asked the Board to reimburse him. President Harmon moved to reimburse Sec/Clerk Rickords \$300 for the computer program. The motion was seconded by FF Wallace and carried by a voice vote.

ADJOURNMENT

There being no further business before the Board, President Harmon moved to adjourn the meeting. The motion was seconded by Sec/Clerk Rickords, carried by a voice vote and approved. President Harmon declared the meeting adjourned at 2:19 p.m.
