# APPROVAL OF TREASURER'S REPORT

Motion by Comptroller Eldridge to sell Hartford Insurance contract with Morgan Stanley since all fees have expired and invest proceeds with Busey Bank Mutual Funds. Motion approved.

#### APPROVAL OF CLERK'S BILLS

Sec/Clerk Rickords reported that at this time no purchase had been made on a new computer. He reported that he consulted with Information Services and advised them what needed to be included on the laptop computer including Office XP and they estimated the cost to be approximately \$2000.00. Comptroller Eldridge advised Sec/Clerk Rickords to proceed with the purchase of the computer. President Short moved that the old computer be sold at auction. The motion was seconded by FF Schafroth, carried by a voice vote and approved.

- A. <u>Fire Pension Refund- Ryan MacZura</u> A pension refund of \$2727.52 was disbursed to Ryan MacZura on March 20, 2003.
- B. Continuation of Legal Services Sec/Clerk Rickords discussed a bill for services received from Attorney James Dobrovolny for \$1968.75 which included attendance at regular scheduled board meetings and \$262.50 for consultation with Comptroller Eldridge on Board composition. President Short moved that the bill be paid. The motion was seconded by Sec/Clerk Rickords, carried by a voice vote and approved. President Short discussed retention of services for every board meeting. Comptroller Eldridge asked Attorney Dobrovolny if we decided that we didn't require his services for every meeting if the Board could still use his services for consultation. Attorney Dobrovolny agreed to the proposal. The Board agreed to discuss continuation of legal services at the next quarterly meeting.
