## 6. OLD BUSINESS

Ms. Novak stated that Urbana now officially has three additional entries in the National Register of Historic places. Elm Street Court, more commonly known as Buena Vista Court on Elm Street, was listed on June 15<sup>th</sup>. The Nathan Clifford Ricker House, 612 W. Green Street, was listed on June 21<sup>st</sup>, and the University of Illinois Library on Gregory Street, was listed on August 11<sup>th</sup>. With these additions, it brings the total number of National Register listings for Urbana to nineteen. Champaign has nineteen listings in the National Register of Historic Places as well.

# 8. NEW BUSINESS

### Presentation of revisions to Historic Preservation Commission Orientation Folders

Mr. Kowalski, Senior Planner, reviewed the revisions to the Historic Presentation Commission Orientation Folders. The Preservation Ordinance, which was adopted by City Council, was also presented to the Commissioners.

# **Update on the Certified Local Government Application**

Mr. Kowalski explained that for the Commission to be certified it means that the Commission is able to participate in the programs that the state agency offers and possibly get funding for efforts to promote

Historic Preservation in Urbana. Being certified also allows the Commission to partake in the activity of reviewing sites for the State Historic Register.

# **Discussion of Historic Walking Tour and Workshop**

Mr. Kowalski suggested that the Commission should have a Historic Walking Tour to spark general interest in history and preservation in the City of Urbana. Mr. Kowalski suggested the West Main Street area and possibly the downtown area. After much discussion, the Commission decided to hold the walking tour on Saturday, October 21<sup>st</sup>, from 10 a.m. to 12 noon. Advertisement of the event could be flyers in downtown business windows, as well as posted information on the City's website. Mr. Shepard suggested trying to get an article in the paper prior to the tour, and possibly some coverage of the actual tour. Mr. Rose suggested that the Commissioner's should actually walk the proposed tour area to get an idea of how much time it would take to participate in the tour, and which area would be the best for the tour. All agreed to walk the proposed tour area and discuss their findings at the next meeting, which was set for Wednesday, September 20<sup>th</sup>.
