1. CALL TO ORDER, ROLL CALL AND DECLARATION OF QUORUM

The Urbana Public Arts Commission was called to order at 4:34 p.m. by Chair Robin Hall. Anna Hochhalter took roll and a quorum was declared present.

2. CHANGES TO AGENDA

There were none.

3. APPROVAL OF MINUTES OF PREVIOUS MEETING

The minutes of the January 12, 2010 meeting were reviewed by the Commission. With no changes proposed, Ms. Hedlund made a motion to approve the minutes. Mr. Lewis seconded the motion. All Commission members present were in favor of approval and the minutes were unanimously approved as presented.

4. PUBLIC INPUT

There was none.

5. COMMUNICATIONS

• Presentation by Staff: Monthly Progress Report

Ms. Hochhalter presented the City staff's monthly progress report to the Commission, outlining current projects, projects with partners and upcoming events. She also introduced the newest members of the Commission, Cheryl Hayden and Mary-Ann Winkelmes.

For an update on current projects, she reported the following:

- The Gallery District Incentive Program was receiving continuing inquiries and business participation.
- With regards to the Urbana Arts Grant Program, the 2009 projects were reported as being underway. Ms. Hochhalter reported that final reports will begin to be submitted in March 2010 and that the City had received 45 grant applications for 2010. She presented to the Commission an overview of the applicants and noted that two juries were being coordinated, the recommendations of which would be given to the Urbana Business Association's "Business Backs the Arts" Committee and Board. The Public Arts Commission, she noted, would review the final recommendations at its March 2010 meeting.
- With regards to the Urbana Sculpture Project, City staff was finalizing agreements with the artists and the installation process with four artists for the Philo Road and Iron Post installations.
- With regards to the Lecture Series, City staff met with the subcommittee to discuss program planning.
- With regards to fundraising, City staff was working to clarify the process by which the Commission can raise funds for the program.
- With regards to the City Building Exhibition Space, City staff had ordered the hanging system for the artwork to be displayed, which was scheduled to arrive on February 11, 2010 and was to be installed shortly after arrival.
- With regards to grants, City staff was working on Illinois Cultural Data Project registration and considering projects for the Illinois Arts Council Program Grant, which would be due March 15, 2010. Project activity would be between September 1, 2010 and August 31, 2011.
- With regards to marketing, the Public Arts Program's Facebook page was reported as having 164 fans. It was also reported that the Program was participating in the News-Gazette's Design-an-Ad program. Ms. Hochhalter announced that the Program's ad would be published in the March 30, 2010 publication.

For projects with partners, Ms. Hochhalter reported the following:

- That the Boneyard Connect, an artist/venue mixer for the 8th Annual Boneyard Arts Festival would take place on Wednesday, February 10, 2010 from 5:30 to 7:30 p.m. at V. Picasso, 214 W. Main St. Ms. Hochhalter noted that the event was to be hosted by the Urbana Business Association and 40 North | 88 West.
