The Urbana Free Library Board of Trustees and The Urbana Free Library Foundation met at a joint meeting held in the Auditorium of The Urbana Free Library on April 9, 2002. The meeting was called to order by Library Board President, Michael Stevenson, at 7:33 p.m.

#### Long Range Planning Committee

Laurie Goscha of Isaksen-Glerum presented the reworked schematic design, which included 15 feet of westward expansion excluded from the prior design.

There was extensive discussion on the new plan.

Discussion centered around the four alternate bid items (modifying building temperature control, roof replacement, installation of hybrid digital/pneumatic controls, and a back-up pump for the reheat system) and deferred building enhancements (an acoustic screen at chillers on the roof, east entry stair repair, limited limestone replacement, exterior tuckpointing and repairs, and removal and replacement of existing window systems). The group also discussed the proposed sprinkler system. The sprinkler system is part of the base bid, but was downgraded from a pre-action system to a standard wet and dry pipe system.

### Foundation Board vote:

It was moved by Carl Webber, seconded by Phyllis Max Spiro, and passed unanimously that the base bid be altered to include (a) a pre-action sprinkler system and (b) modified temperature controls for the staff work areas in the former archives and auditorium.

# Library Board vote

It was moved by Kermit Harden, seconded by William Golden, and passed unanimously that the revised schematic design with the two above items added be approved.
