## Technology

There was discussion about the BTOP grants. Deb sent a letter of commitment for the UC2B round 2 BTOP grant for public computing centers. Deb also is sending a letter of support for ICN, which is submitting a grant for infrastructure which benefits the whole state.

Brian Bell, from Parkland, will meet with staff to discuss ways to make the "start button" available on the public computers without compromising security. He also will offer some input on the use of thin clients in our public computer lab.

The Board discussed the responses to the Drupal RFI. It was the consensus of the Board to wait on hiring a consultant because of budget issues and to revisit the process next fiscal year.

#### **Finance**

The library's non-tax revenue may come in under projections by \$35,000 this fiscal year. This loss of revenue also will affect next year's budget planning. The City has not yet forwarded final target numbers for the FY2011 budget.
