11. NEW PUBLIC HEARINGS

ZBA-00-C-6, request for a Conditional Use Permit filed by Tom Davis. The petitioner is proposing to establish two primary structures on one lot in the IN, Industrial zone at 1212 E. University Avenue.

Chairperson Merritt swore in members of the public body planning to testify before the board.

Mr. Kowalski presented an overview of the case concluding with a staff recommendation that the Zoning Board of Appeals grant the proposed request on the basis that it meets the requirements for granting a Conditional Use Permit as outlined in the staff report.

Mr. Corten asked if the number of parking spaces available might suggest a retail business use. Mr. Kowalski answered that the use of the parking lot would remain virtually the same, which is primarily for office and warehouse space.

Mr. Corten asked about the arrival and departure of large trucks to the site. Mr. Tom Davis, the petitioner, answered that FedEx and UPS trucks stop every day as does the truck that delivers the large shipping containers filled with the telephones Scitec Inc. sells. Mr. Davis went on to explain that all unloading of trucks is done from the back of the building and that parking is sufficient.

Mr. Fitzsimmons moved that case No. ZBA-00-C-6, a request for a Conditional Use Permit, be granted based on the summary of findings as items 1-5 listed in the staff report. Mr. Armstrong seconded the motion.

Ms. Merritt called for a roll call. The vote follows:

The motion passed 5 - 0.
