

**TOWN BOARD OF TRUSTEES  
REGULAR MEETING**

The Cunningham Township Board of Trustees met in regular session at 7:00 p.m., Monday, November 4, 2002 in the Council Chambers of the Urbana City Building at 400 South Vine Street, Urbana, Illinois.

Present at the meeting were Members of the Board: Hayes, Huth, Otto, Patt, Wyman (arrived at 7:07 p.m.) and Whelan – 6; absent: Chynoweth – 1 (excused). Also present were Supervisor Carol Elliott, Assessor Joanne Chester, and Township Attorney Fred Grosser.

There being a quorum, Chair Satterthwaite called the meeting to order at 7:05 p.m.

**MINUTES OF THE PREVIOUS MEETING**

Trustee Patt moved to approve the minutes of the October 7, 2002 regular meeting. The motion was seconded by Trustee Hayes and carried by a voice vote.

**COMMITTEE TO VERIFY BILLS**

Trustee Patt moved to approve Town Fund expenditures in the amount of \$37,009.38 and General Assistance Fund expenditures in the amount of \$25,338.49. The motion was seconded by Trustee Hayes and carried by a voice vote.

**REPORTS OF OFFICERS**

Supervisor Elliott stated that she had passed out a Budget Report prior to the meeting and gave a brief report on the current status.

## **NEW BUSINESS**

Supervisor Elliott presented **Resolution No. T-2002-11-066R: A Resolution Determining the Amounts of Money to be Raised By the Tax Levy For the Year 2002, Collectible in 2003** for Town Board consideration. This is the same resolution that is approved every year, which meets Truth in Taxation regulation. Trust Wyman moved to adopt the resolution. The motion was seconded by Trustee Patt and following debate, carried by a voice vote.

Assessor Joanne Chester presented **Resolution No. T-2002-11-007R: Resolution Approving Continuance of Cunningham Township as an Individual Township Assessment District**. This type of resolution is required every ten years after the census. Trustee Wyman moved to adopt the resolution. The motion was seconded by Trustee Patt. Following debate, the motion carried by a voice vote.

There being no further business to come before the Town Board, Chair Satterthwaite declared the meeting adjourned at 7:15 p.m.
