# TOWN BOARD OF TRUSTEES REGULAR MEETING

The Cunningham Township Board of Trustees met in regular session at 7:00 p.m., Monday, July 7, 2003 in the Council Chambers of the Urbana City Building at 400 South Vine Street, Urbana, Illinois.
