Supervisor Elliott presented **Approval of Revised Day Care Program Rules** for Town

Board consideration. Revisions to the township Day Care program have become necessary due to the

changes in subsidies available to low income families and the increase in the number of day care

providers that offer services to low income families. A survey was sent to approximately 26day care

facilities in Champaign-Urbana. Based on the information from those surveys, Supervisor Elliott

recommended that the daycare program for FY 04 continue to fund facilities serving Urbana families

based on the number of "child care days" reported by the day care facility for families qualifying for

Illinois Department of Human Service subsidies. Revisions in the handbook, application form and

contract have been made to replace any reference to Title XX eligibility to IDHA eligibility.

Following debate, Trustee Patt moved **Approval of Revised Day Care Program Rules**.

The motion was seconded by Trustee Wyman and carried by a voice vote.
