COMMITTEE TO VERIFY BILLS

1. Approval of Auditor Fees for FY 2008 Audit

A recommendation was made to look at possibly negotiating a 3 year contract next time to help reduce fees.

Trustee Barnes made a motion to accept the recommendation and secure the services of Kemper Group for fiscal year 2008. Trustee Roberts seconded. The motion carried by a voice vote.

- State of Illinois Joint Purchasing Program Participation Resolution
 Supervisor Elliott gave report and advised the Town needs to acquire a vehicle for dedicated Town use only. Currently, employees are using their own vehicles which create some liability issues. Joining the program may allow some savings with the purchase of the dedicated vehicle. Trustee Smyth asked that some consideration be given to sharing the vehicle with the Library Board as well.
 Trustee Roberts made a motion to approve joining the program. Trustee Barnes seconded. The motion carried by a voice vote.
- 3. Budget and Appropriation Ordinance Fiscal Year 2008-2009 (Tentative)
 Supervisor Elliott presented the first draft of budget. This tentative budget will need to be made public for 30 days after a notice is placed in newspapers. She would like to tentatively schedule July 7, 2008 meeting for adoption of the new budget.
