# TOWN BOARD OF TRUSTEES MEETING

The Cunningham Township Board of Trustees met in regular session at 7:00 p.m., Monday, July 7, 2008 in the Council Chambers of the Urbana City Building at 400 South Vine Street, Urbana, Illinois.

Physically present at the meeting were Elected Officials: Barnes, Bowersox, Chynoweth, Lewis, Roberts, Smyth, Stevenson, Town Board Chair Laurel Lunt Prussing, and Township Supervisor Carol Elliott., Town Clerk, Phyllis D. Clark. Also present was Township Attorney Fred Grosser and Township Assessor, Joanne Chester.

There being a quorum, Chair Prussing called the meeting to order at 7:02 p.m.

#### MINUTES OF THE PREVIOUS MEETING

Trustee Barnes moved to approve the minutes of the June 2, 2008 meeting and June 16, 2008 special meeting in omnibus fashion. The motion was seconded by Trustee Stevenson. The motion to approve the minutes of both meetings carried by a voice vote.

#### COMMITTEE TO VERIFY BILLS

Supervisor Elliott presented the staff report for both the Town Fund and the General Assistance Fund. Trustee Roberts moved to approve Town Fund bills in the amount of \$34,791.99 and the General Assistance Fund bills in the amount of \$46,691.62. The motion was seconded by Trustee Barnes and carried by a voice vote.

## REPORTS OF OFFICERS

Township Supervisor, Carol Elliott, announced that she is working with Bill DeJarnette, Information Services Manager for the City of Urbana, to develop a financial information website for public review. She cautioned that some client information is sensitive and protected by law. She suggested that summaries be used in place of individual information to protect this sensitive information.

#### PETITIONS AND COMMUNICATIONS

Dianna Visek, 608 W. Pennsylvannia, spoke to the Town Board in favor of posting Township financial information for the public to review.

2. Approval of Staff Salaries

Supervisor Elliott advised that any decision made at that time should be retroactive back to July 1, 2008. Trustee Lewis made a motion to defer to the next Town Board meeting. Trustee Roberts seconded. The motion carried by a voice vote.

3. Approval of Increase of Legal Fees.

Supervisor Elliott gave the staff report and made a recommendation for approval. The fees will increase to \$150.00 per hour for six hours per month or a monthly rate of \$900.00. Any additional hours will be at \$175.00 per hour. Trustee Barnes made a motion to approve. Trustee Lewis seconded. The motion carried by a voice vote.
