3. <u>Carle Foundation v. Illinois Department of Revenue</u>

Township Attorney Grosser stated that he understood that the Urbana City attorney suggested that Grosser might have a conflict of interest in representing both the Township Assessor and the Township in the case. Grosser discussed this and stated that he did not see any conflict which he would have. Grosser stated that if any member of the Township Board had any objection to Grosser representing both, the member should inform the Township Supervisor. Trustee Bowersox stated that he wanted Grosser to represent both the Township and the Township Assessor. Trustee Bowersox stated that if the City Attorney had any basis for his statement about conflict, he should put it in writing.
