TOWN BOARD OF TRUSTEES MEETING

The Cunningham Township Board of Trustees met in session at 7:00 p.m., Monday, July 2, 2012 in the Council Chambers of the Urbana City Building at 400 South Vine Street, Urbana, Illinois.

COMMITTEE TO VERIFY BILLS

Trustee Lewis moved to approve Town Fund bills in the amount of \$50,077.10 and the General Assistance Fund bills in the amount of \$55,486.40. The motion was seconded by Trustee Jakobsson and carried by a voice vote.

1. T-2012-07-002: An Ordinance Approving the Budget and Appropriation Ordinance (Fiscal Year 2012-2012)

Supervisor Elliott presented the staff report. Revenues from real estate taxes are split between the two funds due to increases in General Fund need. Also included in the budget is a 3% cost of living increase for staff.
