- 1. Discussion: Town Board Budget Update

At the request of Trustee Smyth, this meeting was held regarding the current Town Board Budget. Township Supervisor Michelle Mayol addressed the trustees' question and concerns. Trustee Charles Smyth made a motion to direct the Township Supervisor to prepare a new budget allocating an additional \$75,000.00 to Social Service Funding bringing the total balance to \$ 175,000.00. Trustee Eric Jakobsson seconded. Motion carried by voice vote.

The Township Supervisor addressed the Board to have noted on record that she does not agree with the recommendation given by the board. Ms. Mayol clarified the board's recommendation by reading the recommendation twice, communicating to the board that her understanding is to prepare a new budget with the following changes; Changing \$100,000 to \$175,000 to the Social Service Funding and an additional \$50,000 to the Homelessness Program(Rental Assistance).
