**WHEREAS**, currently the Township uses a paper based case management system which is inefficient and cumbersome;

**WHEREAS**, the Township needs a back-up system for case management files in case of fire or damage;

**WHEREAS**, NJS Enterprises Inc. has developed a VisualGA, software used routinely by Illinois Townships including City of Champaign Township, to administer General Assistance.

**WHEREAS**, the cost of Visual GA will be \$8000 the first year and \$1600 per year next year and beyond.

**NOW, THERFORE, BE IT RESOLVED** by the Township Board of the Town of Cunningham, that the Township Board authorizes the Township Supervisor to sign the contract with NJS Enterprises Inc. to purchase the Visual GA software for case management purposes.

The software and related documentation must be treated like any other copyrighted materials with the exception of making copies of the software for backup or archival purposes.
- 3) OTHER RESTRICTIONS: **Cunningham Township** may not rent, lease, or transfer this software and accompanying materials. You may not reverse engineer, decompile, or disassemble the software.
- 4) The software (VisualGA.net<sup>™</sup>) is sold as is without modification. If **Cunningham Township** requires customization to the software to help administer their assistance programs, any changes will be billable at our normal hourly rate of \$175/hr.
- 5) **Cunningham Township** may not use, copy, modify, or transfer the software or any copy in whole or in part, except as expressly provided in this license. All rights not expressly granted are reserved by NJS Enterprises, Inc.

If additional training is needed beyond that there will be a fee of \$175 per hour.
