Township Supervisor spoke about this resolution and said this plot is about a third of an acre, is owned by the City of Urbana and is property for which they have no use at this time. The City and Township will enter into a two year lease for the property, and it will be used for a community garden. This will give people an opportunity to have fresh produce, which is not usually available in food pantries.

Discussion ensued, during which Supervisor Chynoweth responded to questions about the possibility of early morning noise, since the hours for the plot are 5:00am to 10:00pm, seven days a week. Supervisor Chynoweth responded that the noise issue would be covered in orientation for those using the plot.
