AN ORDINANCE LEVYING TAXES FOR ALL TOWN PURPOSES FOR THE TOWN OF CUNNINGHAM, CHAMPAIGN COUNTY, ILLINOIS, FOR THE TAX YEAR 2015, COLLECTIBLE IN 2016

BE IT ORDAINED by the Township Board of the Town of Cunningham, Champaign County, Illinois, as follows:

SECTION 1: That, pursuant to the authority granted by the Township

Code, Illinois Compiled Statutes, Chapter 60, Article 235, and such other

statutes as are applicable, the sum one million, one hundred twenty six

thousand, three hundred and ninety five dollars and zero cents

(\$1,126,395.00) is hereby levied upon all property subject to taxation within

the Township as that property is assessed and equalized, in order to meet and

defray all the necessary expenses and liabilities of the Township as required

by statute or voted by the people in accordance with the law, for such

purposes as:

General Town Fund, \$ 782,948.00 General Assistance Fund \$ 343,447.00

For the tax year 2015, collectible in 2016.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
