AN ORDINANCE FIXING COMPENSATION OF  
OFFICERS AND EMPLOYEES OF THE CITY  
OF URBANA, ILLINOIS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA,  
ILLINOIS.

SECTION 1. That beginning May 1, 1961, the monthly salaries of the following named officers and employees of the City of Urbana, Illinois shall be as follows:

SECTION II. Local Improvement fees on all projects based upon the actual cost of construction of each project, shall be paid into the General Corporate Fund from said projects in lieu of paying such fees to the Corporation Counsel.

SECTION III. All engineering fees from Local Improvements shall be paid into the General Corporate Fund. Extra help employed by the City Engineer on Local Improvements projects shall be paid from the General Fund at an hourly rate to be determined by the City Council.

SECTION IV. Regular street department employees shall receive wages at the rate of \$360.00 per month. Emergency call men in street department shall receive \$385.00 per month. All other employees in the Street Department or working in the sewer or drainage department or electrical department who shall be employed by the City shall receive \$1.75 per hour.

SECTION V. Each member of the Civil Service Commission shall receive \$10.00 per year as payment for his services on the said commission.

SECTION VI. For each regular meeting or special meeting of the City Council attended by him, each Alderman shall receive a compensation of . . . . . \$15.00

SECTION VII. All ordinances or parts of ordinances in conflict herewith, are hereby repealed.
