AN ORDINANCE FOR LOCATION OF  
FIRE HYDRANTS

WHEREAS, the Chief of the Fire Department of the City of Urbana, Illinois, Fire Marshall, recommends to the City Council that fire hydrants be located at the following locations, and

WHEREAS, it appears to be for the best interests of the people of the City of Urbana, Illinois, for public safety and fire protection to have such fire hydrants so located, and

WHEREAS, there is a necessity for the location of fire hydrants at the following specified locations;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS that fire hydrants be located in the City of Urbana, Illinois, at the following locations respectively:

AT A LOCATION ALONG THE WEST SIDE OF SOUTH RACE STREET, BETWEEN IOWA STREET AND INDIANA AVENUE, and on the intersecting line of the South line of the Senior High School Building extended West;

AT A LOCATION ALONG THE NORTH SIDE OF WEST IOWA STREET, at the address of 104 West Iowa Street, and on the intersecting line of the East Line of the Senior High School Building extended North;

AT A LOCATION ALONG THE EAST SIDE OF SOUTH VINE STREET at the North property line of the address of 1202 South Vine Street and opposite the Urbana Junior High School Building;

AT THE NORTHWEST CORNER OF THE INTERSECTION OF CLARK STREET AND BUSEY AVENUE;

AT THE NORTHWEST CORNER OF THE INTERSECTION OF CLARK STREET AND COLER AVENUE; and

AT THE NORTHWEST CORNER OF THE CORNER OF WOOD STREET AND LOCUST STREET.

BE IT FURTHER ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS,

That the City Clerk of said City is hereby directed to send a certified copy of this ordinance to the Northern Illinois Water Corporation.


