

AN ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA,  
ILLINOIS, as follows:

That Schedule VI pursuant to Section 8-1, entitled  
"Through Streets Designated", of Article VIII, entitled "Stop  
and Yield Intersections", of the Urbana Local Traffic Ordinance,  
as amended, be and the same is hereby further amended by adding  
to that schedule the following portion of a street where drivers  
of vehicles shall stop or yield at every intersection when signs  
are erected giving notice thereof:

<u>Name of Street</u>	<u>Between</u>
McHenry	Philo and Race Streets

This Ordinance shall be in full force and effect from  
and after its passage and publication in accordance with the terms  
of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote,  
the "ayes" and "nays" being called, of a majority of the members  
of the City Council of Urbana, Illinois, at a regular meeting of  
said Council.

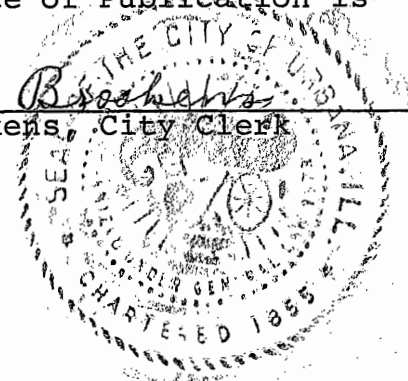
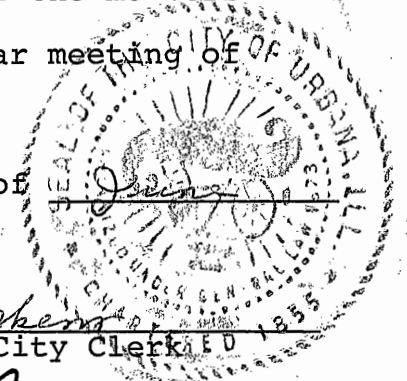
