

ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and includes certain Highways within the Urbana Township, and Notice was given to the Board of Township Trustees and the Township Commissioner of Highways, said Notices being mailed on February 21, 1980, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 P.M., Monday, March 3, 1980, and the Affidavit of mailing such Notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois on the day of February 25, 1980, and

WHEREAS, a written Petition signed by all of the owners of Record and all electors residing therein, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana, and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

Section 1. That the following described real estate, viz:

Lots 398 and 399 in Ennis Ridge Sixteenth Subdivision and also the adjoining street right-of-way of Scovill Street, being 60.00 feet in width, from the West property line of Lot 399 to the East property line of Lot 398, and also the street right-of-way of Philo Road (Il. Rt. 130), being 73.00 feet in width, from the North right-of-way line of Scovill Street to the South property line of Lot 398; said tract containing 1.06 acres, more or less, all being situated in Section 21, Township 19 North, Range 9 East of the Third Principal Meridian, Champaign County, Illinois,

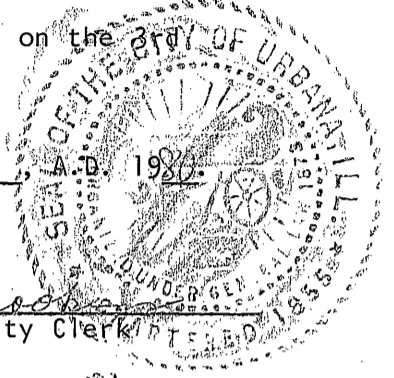
commonly known as 1407 East Scovill Street, Urbana, Illinois, be and the same is hereby annexed to the City of Urbana, Illinois.

Section 2. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 3. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 3rd day of March, A.D. 1980.
