

AN ORDINANCE
AMENDING THE URBANA LOCAL TRAFFIC
ORDINANCE TO PROHIBIT RIGHT TURNS
ON A STEADY RED SIGNAL AT CERTAIN INTERSECTIONS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF
URBANA, ILLINOIS, as follows:

1. That Section 6-3, entitled, "Obedience to No-Turn Signs", of Article VI, entitled, "Turning Movements", of the Urbana Local Traffic Ordinance, as amended, be and the same is hereby further amended to read as follows:

A. Whenever authorized signs are erected indicating that no right or left or U-turn is permitted, no driver of a vehicle shall disobey the directions of any such sign. The placing of such signs in the places indicated in Schedules II, III and IV is herewith approved.

B. Whenever authorized signs are erected indicating that vehicular traffic facing a steady red signal is prohibited from turning right after stopping, as required by law, no driver of a vehicle shall disobey the directions of any such sign. The placing of such signs in the places indicated by Schedule IV-A is herewith approved.

2. That a new Schedule IV-A, entitled, "Right Turns Prohibited on Red", of the Urbana Local Traffic Ordinance, as amended, be and the same is hereby established, and that the following intersections be added to that Schedule where drivers of vehicles facing a steady red signal shall be prohibited from turning right:

<u>Street</u>	<u>Direction</u>	<u>Intersecting Street</u>
Green	Eastbound	Goodwin
Green	Westbound	Goodwin
Goodwin	Northbound	Green
Goodwin	Southbound	Green
Main	Eastbound	Vine

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the City Council of Urbana, Illinois, at a regular meeting of said Council.
