

AN ORDINANCE
AMENDING ORDINANCE NO. 7475-65,
ENTITLED "AN ORDINANCE VACATING
A PORTION OF PARK STREET"

WHEREAS, in Ordinance No. 7475-65, a portion of Park Street was previously vacated; and

WHEREAS, because of new and further developments the extent of the vacation of a portion of Park Street need be reconsidered.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. The corporate authorities hereby determine that the public interest will be subserved by the vacation of an additional portion of Park Street that lies between the East right-of-way line extended of Coler Avenue and the West right-of-way line extended of Orchard Street, all in the City of Urbana, Illinois, except that portion thereof that is located within sixteen (16) feet, north and south, of the centerline of said street, and within two (2) feet below and twelve (12) feet above the highest point located on the centerline of said street between Orchard and Coler Avenue.

Section 2. That the following described portion of Park Street is hereby vacated subject to the conditions set forth herein: All of that portion of Park Street that lies between the East right-of-way line extended of Coler Avenue, and the West right-of-way line extended of Orchard Street, all in the City of Urbana, Illinois, except that portion thereof that is located within sixteen (16) feet, north and south, of the centerline of said street, and within two (2) feet below and twelve (12) feet above the highest point located on the centerline of said street between Orchard and Coler Avenue.

Section 3. The City of Urbana, Illinois, hereby reserves easements upon and under said portions of said street, for the

maintenance and repair of all sewers and drains and all public service facilities which are located on or under the surface of any part of said portion of said street, and a surface easement for pedestrian sidewalks on that portion of said street located within twenty (20) feet from the centerline, north and south, of said street.

The vesting of title in the portions of said street hereby vacated shall be subject to any existing easement or easements for public utilities, their successors and assigns, to operate, maintain, renew and reconstruct their facilities, and as are now operated and maintained in, over or under any portions of said street so vacated, the corporate authorities having determined that it is both necessary and desirable for the public interests that the public services of all of said public utilities be able to be continued by the means of said facilities.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called and entered on the records of this corporate authority, by three-fourths vote of the aldermen and alderwomen holding office who did not abstain from voting on this Ordinance, all in accordance with Ordinance No. 7374-61 of the City of Urbana, Illinois, heretofore adopted and in effect.
