
A RESOLUTION

AGREEMENT

AGREEMENT made by and among the CITY OF URBANA, an Illinois municipal corporation, herinafter called the "the City", and CHAMPAIGN COUNTY FAIR ASSOCIATION, an Illinois not-for-profit corporation, hereinafter called "the Fair", as follows:

1. Fairgrounds. The City will not seek an involuntary annexation of the real estate owned by the Fair as long as said real estate continues to be the site of the annual Champaign County Fair.

2. Surrounding ground. The Fair will not oppose annexation by the City of certain real estate which is adjacent to or near the real estate owned by the Fair.

3. In the event that the City violates this agreement by attempting an annexation of the property owned by the Fair, the Fair shall be entitled to recover all reasonable attorney's fee and costs that it incurs as the result of said attempted annexation.
