

RESOLUTION NO. 9394-R1

**A RESOLUTION
OF SUPPORT FOR JOINT APPLICATION
FOR INTERMODAL SURFACE TRANSPORTATION ENHANCEMENT ACT FUNDS
BY THE CITY OF URBANA AND THE URBANA PARK DISTRICT**

WHEREAS, the City of Urbana has expressed its commitment to the establishment of bicycle paths as illustrated in new capital improvements such as Windsor Road, its commitment to their construction in private developments such as required in the Tabin Annexation Agreement and their designation in the Comprehensive Plan, as amended; and

WHEREAS, through its staff, the City of Urbana, the Urbana Park District, staff of the Champaign Urbana Urbanized Area Transportation Study, the University of Illinois, the City of Champaign, the Champaign Park District, the Prairie Cycle Club, the Conservation Group, the University of Illinois and the Illinois Department of Transportation have jointly developed a new bicycle path map for the City of Urbana designating separate and on-street bicycle systems; and

WHEREAS, and the Urbana Park District has committed to the development of Meadowbrook Park to include a bicycle path system which will interconnect with the City of Urbana system and ultimately with the University of Illinois' and City of Champaign bicycle systems; and

WHEREAS, these planning efforts further reflect the City and Park District's commitment to a community based bicycle path system involving multiple government agencies and user groups in its use and establishment; and

WHEREAS, there are funds available through the Illinois Department of Transportation (IDOT) and the Internodal Surface Transportation Enhancement Act (ISTEA) for the development and improvement of transportation systems such as bicycle paths; and

WHEREAS, the City of Urbana and the Urbana Park District have determined that it is in the best interests of each agency and the residents of the City of Urbana to apply for said funding to further develop an existing system of bicycle pathways.

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. The City Council finds and determines that the facts contained in the above recitations are true.


Section 2. That the Urbana City Council, does hereby

submit a Transportation Enhancement Program grant request in joint sponsorship with the Urbana Park District in the amount of \$355,600 to the State of Illinois Department of Transportation for the purpose of financing 80% of the proposed bikeway path improvements in Meadowbrook Park, and along Windsor Road east of Philo Road as noted in said grant application.

Section 3. The Mayor is hereby authorized and directed to execute any subsequent documents related to the submission of the grant application, and the subsequent receipt of funds through said grant.
